ADVANCE VOTING OPPORTUNITIES

Advance voting will be open at the Esquimalt Municipal Hall, 1229 Esquimalt Road, Esquimalt, BC on Wednesday, November 5, 2008 and Wednesday, November 12, 2008 between the hours of 8:00 am and 8:00 pm each day.

ELECTOR REGISTRATION

There is no need to pre-register to vote as the registration of all electors for this election will take place at the time of voting. You will be required to make a declaration that you meet the following requirements:

- 18 years of age or older
- Canadian citizen
- resident of BC for at least 6 months immediately preceding voting day
- resident of OR registered owner of real property in the Township of Esquimalt for at least 30 days immediately preceding voting day, and
- not otherwise disqualified by law from voting.

Resident electors will also be required to produce **2 pieces of identification** (at least one with a signature). Picture identification is not necessary. The identification must prove both residency and identity.

Non-resident property electors must produce 2 pieces of identification (at least one with a signature) to prove identity, proof that they are entitled to register in relation to the property, and, if applicable, written consent from the other property owners.
