CORPORATION OF THE TOWNSHIP OF ESQUIMALT

BY-LAW NO. 1146

- The submission of questions to electors at the Municipal Elections in 1965.

WHEREAS it is provided by Section 766 of the Municipal Act, being R.S.B.C. 1960, Chapter 255, and amending Acts, that on the recommendation of the Minister, the Lieutenant-Governor in Council may, by Letters Patent, incorporate any area of land within a school district or districts, or any part thereof, and the residents therein, into a regional district.

AND WHEREAS before making a recommendation a copy thereof must be forwarded to the Municipal Council of each Municipality within the proposed regional district,

AND WHEREAS a recommendation has been received by the Municipal Council of the Corporation of the Township of Esquimalt in accordance with the said Section, dated the 8th day of October, A.D. 1965,

AND WHEREAS it is deemed expedient to submit certain questions relating to Regional Parks and Hospitals for the opinion of the owner-electors of the Corporation of the Township of Esquimalt in accordance with the provisions of the said Section 766 of the Municipal Act,

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF ESQUIMALT, in open meeting assembled, enacts as follows:

1. The Returning Officer appointed to preside at the Municipal Elections in the Township of Esquimalt in the month of December, A.D. 1965, is hereby directed to submit the following questions to the owner-electors at the time of the aforesaid Municipal Elections, that is to say:

(a) Question 1:

"Are you in favour of the Corporation of the Township of Esquimalt sharing in the cost of the acquisition of real property under the Regional Parks Act within the proposed Regional District consisting of the Municipalities of Central Saanich, Esquimalt, North Saanich, Oak Bay, Saanich, Sidney and Victoria, and the Electoral Areas of Colwood, Langford, Metchosin, View Royal and Sooke. The total annual cost to all such Municipalities and Electoral Areas (excluding the Electoral Area of Sooke) not to exceed an amount being the product of one-half mill on the total taxable assessed values within such Regional District, and to be shared by such Municipalities and Electoral Areas (with the exception of the Electoral Area of Sooke) on the basis of taxable assessed values."?

(b) Question 2:

"Are you in favour of the Corporation of the Township of Esquimalt sharing in the cost of granting aid for the purpose of purchasing, building, enlarging or equipping hospitals in the proposed Regional District consisting of the Municipalities of Central Saanich, Esquimalt, North Saanich, Oak Bay, Saanich, Sidney and Victoria and the Electoral Areas of Colwood, Langford, Metchosin, Sooke and View Royal with the total annual cost to all such Municipalities and Electoral Areas not to exceed an amount being the product of two mills on the total taxable assessed values within such Regional District and to be shared by such Municipalities and Electoral Areas one-half on the basis of taxable assessed values and one-half on the basis of population."?

2. This By-law may be cited as the "Regional District Submission By-law, 1965".
