

CORPORATION OF THE TOWNSHIP OF ESQUIMALT

BY-LAW NO. 1773

BEING a By-law to authorize the construction and equipping of a library building within the Municipality of Esquimalt and the borrowing of a portion of the estimated cost thereof.

WHEREAS it is deemed desirable and expedient to construct and equip a library building on a site owned by the Corporation within the Municipality of Esquimalt;

AND WHEREAS the estimated cost of constructing and equipping the said library building, including expenses incidental thereto is the sum of \$950,000.00;

AND WHEREAS a grant in aid has been offered to the Corporation by the Government of Canada through the Employment Creation Grant Programme in an amount not to exceed one-half of the actual cost or the sum of \$475,000.00, whichever is the lesser, towards the cost of constructing and equipping a library building;

AND WHEREAS the Council proposes to appropriate from the Reverted Property Reserve Fund of the Corporation a sum not exceeding \$250,000.00 for the purpose of funding in part the construction and equipping of the said library building;

AND WHEREAS the amount of the debt to be created by this By-law is the sum of \$225,000.00;

AND WHEREAS the amount of the assessed value for general municipal purposes of the taxable land and improvements for the current year and for each of the two years immediately preceding the current year were:

1984	\$ 357,091,770
1983	\$ 50,637,209
1982	\$ 59,776,984

AND WHEREAS the amount of the authorized debenture debt of the Municipality as at May 15, 1984 is \$2,874,218.74 of which \$1,892,218.74 is existing outstanding debt and \$982,000 is authorized and unissued debenture debt, and none of the principal and interest of the debenture debt of the Municipality is in arrears;

AND WHEREAS the maximum term for which debentures may be issued to secure the debt created by this By-law is 20 years;

NOW, THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF ESQUIMALT, in open meeting assembled, hereby enacts as follows:

1. The Council is hereby empowered and authorized to undertake and carry out or cause to be carried out the construction and equipping of a library building in accordance with the general plans approved by the Council of the Corporation of the Township of Esquimalt and to do all things necessary in connection therewith at a cost not to exceed \$950,000.00 and without limiting the generality of the foregoing:
  - (a) To borrow upon the credit of the Municipality a sum not exceeding \$225,000.00.
  - (b) To acquire all such real property, easements, rights-of-way, licences, rights or authorities as may be required or desirable for or in connection with the construction and equipping of the said library building.
2. This By-law may be cited as the "LIBRARY BUILDING CONSTRUCTION AND LOAN AUTHORIZATION BY-LAW, 1984".

Read a first time by the Municipal Council by an affirmative vote of not less than two-thirds on 28th May, 1984.

Read a second time by the Municipal Council by an affirmative vote of not less than two-thirds on 28th May, 1984.

Read a third time by the Municipal Council by an affirmative vote of not less than two-thirds on 28th May, 1984.

APPROVED by the Inspector of Municipalities on 29th May, 1984.

RECONSIDERED, ADOPTED and FINALLY PASSED by the Municipal Council by an affirmative vote of not less than two-thirds on 9th July, 1984.
