## CORPORATION OF THE TOWNSHIP OF ESQUIMALT

### **BYLAW NO. 2459**

A Bylaw to authorize the execution of an Addendum to the Greater Victoria Public Library Agreement.

WHEREAS a Municipal Council may by bylaw pursuant to Sections 176 and 246 of the *Local Government Act* enter into an agreement to provide for the operation of a public library;

AND WHEREAS it is deemed expedient that the Corporation of the Township of Esquimalt enter into an addendum to the agreement with the Greater Victoria Public Library Board and the Municipalities of Central Saanich, Colwood, Highlands, Langford, Metchosin, Oak Bay, Saanich and Victoria for the aforesaid purpose;

NOW, THEREFORE, THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF ESQUIMALT, in open meeting assembled, enacts as follows:

- 1. This Bylaw may be cited for all purposes as the "LIBRARY AGREEMENT ADDENDUM AUTHORIZATION BYLAW, 2001, NO. 2459."
- 2. The Corporation of the Township of Esquimalt is hereby authorized and empowered to enter into an addendum to the agreement with the Greater Victoria Public Library Board and the Municipalities of Central Saanich, Colwood, Highlands, Langford, Metchosin, Oak Bay, Saanich and Victoria in the form attached hereto as Schedule "A".
- 3. The Mayor and Corporate Administrator of the Corporation of the Township of Esquimalt are hereby authorized to execute the Addendum to the Greater Victoria Public Library Agreement.

# ADDENDUM to the LIBRARY OPERATING AGREEMENT (the "Agreement")

Dated: January 1, 1999

### WHEREAS:

- The Board has recommended the admission of The Corporation of the District of Central Saanich ("District of Central Saanich") as a new party under paragraph 9.1 of the Agreement
- 2. The admission of the District of Central Saanich has been approved by Council resolution of municipalities which, together, were required to pay in the previous year two-thirds of the net operating cost of the Board, as required under paragraphs 4.5 and 9.5 of the Agreement
- 3. The District of Central Saanich has been authorized by bylaw to enter into the Agreement

### IT IS THEREFORE AGREED THAT:

- 4. The District of Central Saanich become a party to the Agreement with effect from January 1, 2002
- 5. This addendum may be signed in counterparts that:
  - (a) have the same effect as if the parties had all signed the same document;
  - (b) will be construed together to be an original document; and
  - (c) will constitute one and the same Agreement.
