## CORPORATION OF THE TOWNSHIP OF ESQUIMALT

## **BYLAW NO. 2519**

A Bylaw to authorize the execution of an Addendum to the Greater Victoria Public Library Operating Agreement to admit the Town of View Royal as a party to the Agreement

WHEREAS the Council may by bylaw pursuant to sections 176 and 246 of the *Local Government Act* enter into an agreement to provide for the operation of a public library;

AND WHEREAS Bylaw No. 2345, cited as the Library Agreement Authorization Bylaw, 1998, No. 2345, authorized the execution of the Greater Victoria Public Library Operating Agreement;

AND WHEREAS the Board of the Greater Victoria Public Library has recommended that the Town of View Royal be admitted as a new partner to the said Agreement;

AND WHEREAS it is deemed expedient that the Corporation of the Township of Esquimalt enter into an Addendum to the Agreement with the Greater Victoria Public Library Board and the Municipalities of Central Saanich, Colwood, Highlands, Langford, Metchosin, Oak Bay, Saanich, Victoria and View Royal for the aforesaid purpose;

NOW, THEREFORE, THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF ESQUIMALT, in open meeting assembled, enacts as follows:

- 1. This Bylaw may be cited for all purposes as the *Library Agreement Addendum Authorization Bylaw, 2002, No. 2519.*
- 2. The Council of the Corporation of the Township of Esquimalt is hereby authorized and empowered to enter into an Addendum to the Library Operating Agreement with the Greater Victoria Public Library Board and the Municipalities of Central Saanich, Colwood, Highlands, Langford, Metchosin, Oak Bay, Saanich, Victoria and View Royal, in the form attached hereto as Schedule "A".
- 3. The Mayor and Corporate Administrator are hereby authorized to execute the Addendum to the Greater Victoria Public Library Operating Agreement.

# ADDENDUM to the LIBRARY OPERATING AGREEMENT ("the Agreement") dated January 1, 1999

### WHEREAS:

- 1. The Board has recommended the admission of The Town of View Royal ("View Royal") as a new party under paragraph 9.1 of the Agreement

  - (a) have the same effect as if the parties had all signed the same document;
  - (b) will be construed together to be an original document; and
  - (c) will constitute one and the same Agreement.
