

CORPORATION OF THE TOWNSHIP OF ESQUIMALT

BY-LAW NO. 810

By-Law No. 810.

BEING a By-law to authorize the Corporation of the Township of Esquimalt to sell certain lands within the Corporate limits of the Municipality.

WHEREAS the Corporation of the Township of Esquimalt is seized in fee simple of the lands described in Sections 1 to 3 hereof, both inclusive,

AND WHEREAS the said lands and premises are no longer required for Municipal or other public purposes and are free from any reservation or dedication under the terms of Sections 465 and 466 of the "Municipal Act",

AND WHEREAS there are no buildings or structures of any kind on the said lands and premises,

AND WHEREAS the Council of the Corporation has power to sell and dispose of the said lands by by-law,

AND WHEREAS the persons named in the said Sections 1 to 3 hereof, both inclusive, have agreed to purchase the lands the legal descriptions of which are respectively stated herein for the prices there stated and the said persons have paid the said purchase monies to the Corporation.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF ESQUIMALT enacts as follows:

1. It shall be lawful for the Corporation of the Township of Esquimalt to sell, grant and convey Lot 11, Block 2, Esquimalt District, Plan 4709 for the sum or price of \$2,250.00 of lawful money of Canada payable by Arthur Hutchings Edmonds and Marjorie Ann Isabel Edmonds, both of 527 Joffre Street, Esquimalt, British Columbia, in cash.
2. It shall be lawful for the Corporation of the Township of Esquimalt to sell, grant and convey Lot 12, Block 2, Esquimalt District, Plan 4709 for the sum or price of \$2,000.00 of lawful money of Canada payable by Jack Hawkins Moffat and Frances Anna Moffat, both of 832 Leslie Drive, Victoria, British Columbia, in cash.
3. It shall be lawful for the Corporation of the Township of Esquimalt to sell, grant and convey Lot 13, Block 2, Esquimalt District, Plan 4709 for the sum or price of \$1,900.00 of lawful money of Canada payable by William Henstock Pollard, 2091 Carnarvon Street, Victoria, British Columbia, in cash.

4. The Reeve and the Municipal Clerk of the Corporation of the Township of Esquimalt are hereby authorized and directed to execute and deliver deeds of conveyance granting and conveying the said lands to the persons named herein.
5. This By-law may be cited as the "Land Sale By-law (No. 20) 1958".
