

CORPORATION OF THE TOWNSHIP OF ESQUIMALT

BY-LAW NO. 841

BEING a By-law to provide for the assumption by the Corporation of certain levies to be made under the "Kinver Drainage District By-law No. 1, 1947".

WHEREAS by By-law No. 464 of the Corporation, being the "Kinver Drainage District By-law No. 1, 1947", the Corporation was authorized to construct a drainage system for a certain portion of the Municipality in the said By-law described;

AND WHEREAS the said By-law provided that the cost of the said work be raised by a special levy upon the lands benefited thereby;

AND WHEREAS certain debentures were issued by the Corporation to secure the monies borrowed to provide for the cost of the said work;

AND WHEREAS there will remain in the hands of the Corporation as a reserve for the payment of debt charges and the redemption of the said debentures at December 2nd, 1958, the sum of one thousand two hundred and seventy-two dollars and twenty-four cents (\$1,272.24);

AND WHEREAS the works aforesaid and the By-law aforesaid were done and passed under the powers conferred by Section 65 of the "Municipal Act", being Chapter 232 of the Revised Statutes of British Columbia 1948;

AND WHEREAS by virtue of section 615 of the "Municipal Act" being Chapter 42 of the Statutes of British Columbia 1957, the Council may, with the approval of the Inspector of Municipalities, assume all future levies pertaining to the owners' portion of the cost of any work replaced by works constructed for the general benefit of the Municipality.

AND WHEREAS all works similar to the works under the "Kinver Drainage District By-law No. 1, 1947" are now being provided for the general benefit of the Municipality from general funds.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF ESQUIMALT enacts as follows:

1. The Corporation of the Township of Esquimalt shall from the 2nd day of December, A.D. 1958, assume all future levies pertaining to the owners' portion of the cost of the work authorized under By-law 464 of the Corporation, being the "Kinver Drainage District By-law No. 1, 1947".

2. The reserve held by the Corporation in the amount of one thousand two hundred and seventy-two dollars and twenty-four cents (\$1,272.24) for the payment of debt charges and the redemption of debentures issued under the said By-law shall be applied to the redemption of the said debentures issued under the said By-law.

3. This By-law may be cited as the "Kinver Drainage District Levy Assumption By-law, 1958".
