POSITION FUNCTION

Perform life guarding functions to ensure the safety of patrons using the swimming pool.

KEY DUTIES

Monitor patrons using the pool, pool deck, weight room, saunas and change rooms; enforce pool rules and regulations; greet patrons; assist patrons to put on and remove life jackets and other equipment; respond to enquiries from patrons regarding pool activities.

Set up and take down pool lanes, ropes and signs; ensure pool is cleared after each swim; ensure pool and all rooms are cleared after last swim of the day; coordinate games for children as attendance permits.

Clean pool deck, change rooms, first aid room and staff room; vacuum and wipe down weight room; clean patio furniture; remove and store equipment such as life jackets, surfboards, toys and bleach bottles; deal with minor locker problems; ensure freezer is stocked with ice; apply ice to patrons as required.

Ensure first aid equipment is complete; use oxygen, spine board, pocket mask and first aid kit in the event of an emergency; update the pool log by recording any incidents.

Perform related duties where qualified.
