Project Overview

In January 2017, the Capital Regional District and the Township of Esquimalt agreed on an amenity funding package associated with locating the wastewater treatment plant at McLoughlin Point. A one-time Capital Regional District contribution of \$17 million—the McLoughlin Point Amenity Reserve Funds—will be used for capital projects in:

- 1. Waterfront parks = \$7M
- 2. Downtown recreation facilities = \$5M
- 3. Downtown emergency services and public safety facilities = \$5M

More information about the funding criteria for the three funding categories above is included in Appendix A.

A public engagement process (see Figure 1) was undertaken by the Township to inform the use of the funds. Using input from the public engagement process, established selection criteria and the funding criteria, Council will determine which projects will receive funding.

What we did

Engagement Opportunities

Round 2 of the community engagement process focused on gauging support for the ideas that emerged through Round 1 engagement. Input in Round 2 was gathered through a survey tool that was accessible online and at a mobile engagement booth in place at key locations and community events from May 24 to September 23, starting with the Esquimalt Farmer's Market and ending with the Children's Story Festival. In total, 1771 people responded to the survey, with 835 responding that they live in Esquimalt and 934 stating they live outside of Esquimalt. 














Esquimalt Gorge Park






Saxe Point Park






Macaulay Point Park











Q10. For Esquimalt Recreation Centre, which 3 items below would you recommend be developed, enhanced or expanded with available funding?






Q11. For Archie Browning Sports Centre, which 3 items below would you recommend be developed, enhanced or expanded with available funding? (Choose up to 3)




Q12. For Bullen Park, which 3 items below would you recommend be developed, enhanced or expanded with available funding?





Appendix A: McLoughlin Point Amenity Reserve Funds Details

THE OPPORTUNITY: A \$17M COMMUNITY CONTRIBUTION

Esquimalt has received a one-time contribution of \$17M from the Capital Regional District (CRD) as part of the McLoughlin Point Amenity Reserve Funds. All funds must be invested within roughly five years. The negotiated agreement clearly establishes how the Township must use these funds.

\$7M = Waterfront Park Improvements

To be invested in capital improvements to waterfront parks.

- Where? Macaulay Point, Saxe Point, Esquimalt Gorge Park, or other approved waterfront parks
- What's in? New, expanded or enhanced amenities (e.g., playgrounds), infrastructure (e.g., pathways), buildings/structures (e.g., pavilions, bathrooms), and other capital improvements, including waterfront park acquisition
- What's out? Operations, programming, maintenance, events.

\$5M = Downtown Recreation Facility Improvements

To be invested in additions or capital improvements to community recreation facilities.

- Where? Archie Browning Centre, Esquimalt Recreation Centre, Bullen Park
- What's in? New, expanded or enhanced amenities (e.g., sports fields, pool, courts, rink), infrastructure, and/or buildings
- What's out? Operations, programming, equipment, maintenance, events.

\$5M = Facilities for Emergency Services and Public Safety

To be invested in new, expanded or enhanced emergency services facilities.



- What's in? New, expanded or enhanced emergency services facilities with the potential to integrate other uses (e.g., apartments or offices) on the upper floors.
- What's out? Operations, programming, equipment, maintenance, events.


What is your age?


Where do you live?







Righting a historical wrong, by rebuilding Japanese teahouse in Esquimalt

The Township of Esquimalt is being presented with an opportunity to right a historical wrong and create something new to serve the present.

Historical researchers and a Japanese cultural association are hoping the municipality will agree to rebuild a Japanese teahouse in Gorge Park on the same spot occupied by one looted and destroyed during the Second World War. But they also want to see a community centre to benefit all park users.

"To some extent, you could say this would be some righting of a historical wrong," said Tsugio Kurushima, president of the Victoria Nikkei Cultural Society. "But we also want to promote something that would be useful for the whole community."

Kurushima is spearheading a move to persuade Esquimalt to rebuild the teahouse using a portion of the \$17 million it has received as compensation for taking on the regional sewage treatment plant now under construction at McLoughlin Point.

He would like to see a facility to recreate the original teahouse, offer snacks and drinks for park users, and provide other space for activities such as meetings or social events.

"The teahouse could be part of a multi-purpose structure that could be used by the whole community," said Kurushima.

"It could address two birds with one stone," he said. "It would right a wrong that took place in the Second World War and build an amenity that would improve the park."

Assisting with research work and commemoration of the original teahouse is a federally funded, national project called Landscapes of Injustice.

Kaitlin Findlay, research co-ordinator and historian at the University of Victoria, said the original teahouse dated back to 1907. A traditional Japanese garden, the first to be created in Canada, was built alongside it in the 1920s.

Findlay said brothers Hayato and Kensuke Takata, who arrived in Victoria in their teens, owned the teahouse and made it a prominent part of Victoria's social scene. Beyond the traditional teahouse, it also included a dance hall, a dining room, a games area and merry-go-round.

But in 1942, the Canadian government began uprooting Japanese Canadians from the West Coast and sending them to internment and work camps in the Interior or the Prairies. An exclusion zone along the coast was enacted.

Victoria, with a small Japanese Canadian community of 270 to 300, was no exception. The Takata family was uprooted and

With the coming Accessible Canada Act canada.ca/en/employment-social-development/programs/accessible-people-disabilities/act-plain-language-summary.html#section2 please take seriously your responsibility to use some of the McLoughlin Amenity Funds as an opportunity to identity gaps and act to improve accessibility.

To at least meet the current standard of other Capital Region municipal pools you would need to:

Build two new accessible change rooms that are up to the standard of other facilities. Rooms need to be large enough and well laid out enough to allow both a water chair and power wheelchair in the room and it still be safe for a client and attendant to move around and access all areas of the room. Rooms need a full length shower and change table accessible to a shower head with safety side rails and adjustable height, overhead lift with xy tracking that reaches the toilet and change table. You currently only have one change room for clients who can't stand. It is too small too allow two wheelchairs in the room. You change table is too short to hold a person of average height, has no safety rails, is not height adjustable and has no showerhead available for showering those who can't sit to shower. Depending on how your plumbing and weight bearing walls, it would be an excellent idea in as many family change rooms as possible to remove the lips to entering the family change room showers to allow level entry for those with walkers and install shower chairs that fold up (like in the in current accessible bathroom). Even better would be to remove the middle wall and replace it with a moveable curtain to make the

changerooms square and roomier for those with walkers and wheelchairs that are able to transfer but find the rooms to crowded and therefore a fall hazard and unsafe

Install a wheelchair ramp or overhead lift to allow access to the main pool for clients who can not stand and pivot safely on a wet surface. Those who can't stand are unable to access your main pool.

Install an overhead lift to access the hot tub. Those who can't stand must currently be physically lifted up into your portable lift chair which limits them to having an attendant with sufficient strength to lift them and poses a risk of injury for their attendants. This can also be dangerous for those with minimal core strength who can't sit without the risk of sliding out of the seat, and requires them to straighten their legs in order to clear the side of the tub, which can be painful for many with arthritis or others with limited knee mobility. The mobile lift is also heavy and cumbersome and moving it poses a risk of injury for your pool staff.

Install additional grab bars in hot tub and install some grab bars in the small pool seating bench. See Panorama as an excellent example.

Install two support rails the entire entrance into the hot tub. There are currently only rails on the stairs, which means people who normally walk with the support of a walker must walk a distance on a wet surface with no support which poses as significant and unnecessary fall risk.

Panorama, Commonwealth and even Juan de Fuca are all excellent examples of accessible pools and change rooms. A lot could be learned by a trip to view these facilities.

It is concerning both that your Accessibility Awareness Committee was dissolved almost a decade ago with no replacement listed esquimalt.ca/municipal-hall/committees/access-awareness-committee and also that their 2009 Accessibility Audit esquimalt.ca/sites/default/files/docs/municipal-hall/accessibility audit report 2009.pdf came to the conclusion that "the swimming pool is an exemplary model of accessibility and inclusion."

This report incorrectly states that there is a ramp to access the main pool. There is not. The main pool is only accessible by citizens who can stand and turn on a wet surface with no support bars in an exhausted state after exertion of exercising. Those without these abilities can not use the main pool, and some who currently do use the main pool do so face the very serious safety risk of falling and injuring both themselves and the recreation center staff and other support people who are assisting them.

Your accessibility report fails to mention that every single other municipal pool has overhead lifts or ramps that allow patrons to access both their pools and hot tubs. It fails also to mention that there is only one accessible change room with an overhead lift at Esquimalt, in comparison to Juan de Fuca, Panorama and Commonwealth that have two or three change rooms with overhead lifts. Your accessible change room is also the smallest and most cramped and does not include several of the amenities that are becoming standard in a safe accessible change room.

Those with disabilities have a right to access your facilities safely. A survey to determine the popularity of ideas won't catch these access needs because those with limited mobility are a minority with specialized knowledge. Those with disabilities and those who support them are often working hard to get through their daily life without taking on the extra work of communicating what would make their life better. The general population is often unaware what is needed to make a facility accessible.

Esquimalt pool is particularly valuable to those with disability due to the warmer temperatures and has great staff. Most with limited mobility also live with significant pain and warm water can significantly relieve their suffering and associated stress of chronic pain, while increasing their mobility and function. Pools are key to the physical, emotional and social health of many with limited mobility who are often unable to participate in most other forms of exercise.

The more limited someone's mobility becomes, the more vital it is to their wellbeing and survival that they still be able to access the pool. It is a cruel and unnecessary loss to be unable to access the pool just when we need it most. It is important to remember that those of us who are currently temporarily able bodied will all need accessible facilities in the future in an increasingly aging society.

In the decade that I have brought clients to this pool, during the many times I've overheard other raise concerns about limited accessibility, staff repeatedly site cost as the reason that the pool is inaccessible. I hope you use this fund as an opportunity to change that.

Thanks for considering the rights of our disabled citizens to access public spaces. I look forward to receiving a response. There was no directions about where to direct feedback about the McLaughlin Fund, so I'd appreciate it if you would forward my email on (and cc me), if there are other people who can better respond.

Thank you for the work done so far on the McLoughlin Amenity fund. There has been a lot of good progress with a lot of community consultation.

I do like much of what is in the current amenities survey, but as well, it is very limited set from all of the topics that were submitted.

There were many other areas identified for funding as well.

I would like to see \$1M of the \$17M of funds put aside for capital grant fund for submissions from Esquimalt residents.

As part of this, I would like the following considered as examples:

I would also like to see \$300K set aside for capital costs of deer management. Once the deer management survey is done in 2 years, the next thing will be that there is no funds for deer management. Let's please think ahead as we know the costs that Oak Bay have had so far for tracking and immuno-contraception. There will be capital costs for deer management. Please put the money aside now. This definitely could have been covered as part of public safety for the parks. There are ticks in the parks. Dogs are getting them removed on a regular basis. Check with the Esquimalt Medical Center. Disappointing that many of the other topics from our community have not been addressed.

Also, please put \$30K aside for Public safety in the area of our parks especially Bullen Park. There is a capital cost for radar speed signs and software system. This should have been covered as part of public safety for the parks.

Also a \$1M could have been set aside for grant program for I&I in support of Gorge Park swimming.

I would also really like to see proper full coverage of Macaulay Park with Shaw Go Wifi for Public Safety and for tourism. This should include a tourism / public safety webcam as part of BlockWatch 2.0 program.

As mentioned, I would like to see \$1M is set aside for general improvements for the next 3 years including my topics above.

The way the survey is written, if we do not agree with the selection, we have no way to provide our comments. I would like this added to the next McLoughlin Amenities survey.

A Public and Historical Amenity for Esquimalt A Memo For Esquimalt Council from Dr. Jordan Stanger-Ross, University of Victoria

Seventy-five years after looting destroyed Canada's first Japanese garden and teahouse in Esquimalt, the Township has an opportunity to create a new public amenity for local residents and to rebuild a community landmark. The Victoria Nikkei Cultural Society, supported by UVic's Landscapes of Injustice research project, urge Council not to miss this opportunity: use a portion of the McLoughlin Amenity funds to build a multi-purpose facility in Esquimalt Gorge Park that will provide a vital amenity in the under-serviced north end of the Township while at the same time celebrating our diverse cultural heritage and redressing an historical wrong.

The historical case: In 1907, the first traditional Japanese garden in Canada opened in what today is Esquimalt Gorge Park. The garden was designed by Isaburo Kishida, who would go on to create the iconic Japanese section of Butchart Gardens. Alongside Esquimalt's original garden was a Japanese teahouse, a beloved attraction run by Esquimalt locals, the Takata brothers. As one visitor later recalled, "that was a place—something quite wonderful . . . The Japanese Tea Gardens were visited by tens of thousands of people."

What followed is a dark mark on local history. After decades of operation, the teahouse was destroyed by local looters, vandals, and rioters in the 1940s. The results shocked federal officials. An inspector who visited site in May 1944 described the premises as, "just a wreck . . . wanton destruction has taken place." The fate of Esquimalt's teahouse offers important historical lessons. First, that Esquimalt has a long history of cultural diversity of which Japanese Canadians were an important part. Second, when that cultural diversity came under attack in the 1940s, local residents (not just distant federal officials) were responsible.

The contemporary case: Esquimalt is rightly renowned for the exemplary recreational facilities in the south end of the Township. But residents of the north end can feel isolated from these amenities, an imbalance that may be exacerbated with the redevelopment of the area surrounding Municipal Hall. We propose a multi-purpose amenity in the Gorge Park, which in its design will evoke the lost teahouse. Programming will allow the teahouse to serve as a hub for Nikkei tea ceremonies and cultural activities, but, at the same time, it could serve diverse recreational needs and attract residents to one of the Township's remarkable natural environments.

Public response: Today, local residents have responded with overwhelming positivity to this proposal. Despite the complexity of this topic, and the necessity of historical context, the teahouse has, we understand, received a significant share of public voting. Public response to grassroots initiatives, including our booth at the farmer's market, has also been resoundingly supportive. A post on the Esquimalt Community Connection Facebook Page in August received 71 likes and almost uniformly positive comments. With the leadership of your Council, this idea will receive popular support today and create a legacy of which we can be proud.

Personal note: As a resident of Esquimalt, an historian of British Columbia's 1940s, and a devoted user of our Township's public parks and amenities, I am personally delighted by this opportunity. I hope the Council is able to support this positive proposal by the VNCS.
