

## CORPORATION OF THE TOWNSHIP OF ESQUIMALT

### BYLAW NO. 2901

#### A Bylaw to establish a McLoughlin Point Amenity – Recreation Improvements Reserve Fund

WHEREAS Section 188(1) of the *Community Charter* provides that a Council may, by bylaw, establish a reserve fund for a specified purpose and direct that money be placed to the credit of the reserve fund;

NOW, THEREFORE, THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF ESQUIMALT, in open meeting assembled, enacts as follows:


1. This Bylaw may be cited as the **MCLOUGHLIN POINT AMENITY – RECREATION IMPROVEMENTS RESERVE FUND BYLAW, 2017, NO. 2901.**
2. There shall be and is hereby established a reserve fund to be known as the **McLoughlin Point Amenity – Recreation Improvements Reserve Fund.**
3. An amount equivalent to \$5,000,000 [FIVE MILLION DOLLARS] shall be deposited to the credit of this fund and shall be used for the addition or improvement of public and/or community space within the recreation facilities in the Township.
4. These funds shall only be expended in relation to lands made available for public recreation or other community use, and which are owned by the Township in fee simple, or granted/dedicated as park (including but not limited to Archie Browning Centre and Bullen Park) and there shall be no intent to provide commercial space to business, and the expenditure of funds shall not violate the assistance to business restrictions under the Community Charter.
5. Money in this fund, and interest earned on it, shall only be used to fund capital expenditures which may include design development costs and engineering, consultation and professional fees but does not include operating costs.
6. The Council may, at any time after the second anniversary of the Amenity Reserve Fund Administration Agreement and after conducting applicable public consultation and related planning processes, reallocate up to 20% the amount contributed to this Reserve Fund to another of the McLoughlin Point Amenity Reserve Funds, but may not transfer or loan the amounts to other Township reserves.
7. All expenditure of money from the McLoughlin Point Amenity – Recreation Improvements Reserve Fund shall be provided for in the annual Financial Plan, or annual Financial Plan as amended.
