

CORPORATION OF THE TOWNSHIP OF ESQUIMALT

BY-LAW NO. 1845

BEING a By-law to remove a portion of  
Memorial Park land in reservation.

WHEREAS the lands hereinafter described were reserved as and for a public park or recreation ground by By-law No. 1657 being a By-law of the Corporation cited as the "Memorial Park Reservation By-law, 1980" and adopted pursuant to subsection (1) of Section 532 of the "Municipal Act", R.S.B.C., 1979, cap. 290, and presently comprise a portion of the public park or recreation ground commonly known as "Memorial Park"; and,

WHEREAS it is enacted by subsections (2) and (3) of the said Section 532 of the "Municipal Act" that a reservation placed on land pursuant to the aforesaid subsection (1) of the said Section 532 may be removed by a By-law adopted by an affirmative vote of at least two-thirds of all the members of the Council, with the approval of the Minister of Municipal Affairs; and

WHEREAS it is deemed expedient in the public interest to remove the reservation placed on the aforesaid lands as aforesaid:

NOW, THEREFORE, THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF ESQUIMALT, in open meeting assembled, enacts as follows:

1. That the reservation placed on the lands hereinafter described by the above recited By-law No. 1657 be and the same is hereby removed.
2. The lands from which the said reservation is by this By-law intended to be removed are:  
  
Lots 243 and 244, Suburban Lot 41, Section 11, Esquimalt District, Plan 2854.
3. This By-law may be cited as the "MEMORIAL PARK RESERVATION REMOVAL BY-LAW, 1987".

Read a first time by the Municipal Council by an affirmative vote of not less than two-thirds on 9th February, 1987.

Read a second time by the Municipal Council by an affirmative vote of not less than two-thirds on 9th February, 1987.

Read a third time by the Municipal Council by an affirmative vote of not less than two-thirds on 9th February, 1987.

Approved by the Minister of Municipal Affairs on 11th March, 1987.

RECONSIDERED, ADOPTED and FINALLY PASSED by the Municipal Council by an affirmative vote of not less than two-thirds on 11th May, 1987.
