

CORPORATION OF THE TOWNSHIP OF ESQUIMALT

BY-LAW NO. 576

BEING a By-law to authorize the Corporation of the Township of Esquimalt to sell certain lands to Her Majesty The Queen in the Right of Canada represented by The Honourable the Minister of National Defence.

WHEREAS the Corporation of the Township of Esquimalt is seised in fee simple of the lands hereinafter described the same being registered under Certificates of Title No. 224580-I and No. 224581-I;

AND WHEREAS the said lands comprise the soil and freehold of certain highways or portions of highways within the said Township of Esquimalt abandoned by Orders of the Lieutenant-Governor-in-Council vesting the title thereto in said Corporation of the Township of Esquimalt in order that such lands might be granted and conveyed by said Corporation of the Township of Esquimalt to Her Majesty the Queen in the Right of Canada represented by the Honourable the Minister of National Defence;

AND WHEREAS by reason of the value of the said lands and by reason of the population figure according to the last decennial census for the Corporation of the Township of Esquimalt this By-law does not require the assent of the electors of the said Corporation;

THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF ESQUIMALT enacts as follows:

1. It shall be lawful for the Corporation of the Township of Esquimalt to grant and convey to Her Majesty the Queen in the Right of Canada represented by the Honourable the Minister of National Defence the lands hereinbefore referred to the same being described as:
  - (a) The whole of Antrim Street, all that part of Sturdee Street extending North of the prolongation of the Southerly boundary line of Parcel "A" of Suburban Lots 46 and 52, that portion of Astle Street between Nelson Street and the Westerly boundary line of Constance Avenue, and that portion of Nelson Street extending North of the prolongation of the Southerly boundary line of Amended Lot 78, Plan 2854 the same being shown outlined in red on the "Plan of Antrim Street and parts of Sturdee, Nelson and Astle Streets as shown on Plan 2854, Suburban Lots 44 and 45" made by J.R.C. Hewett and dated the 10th day of July, 1952; and
  - (b) All that part of Canteen Road lying to the West of the easterly boundaries of Suburban Lots 25 and 55, Esquimalt District, the same being shown outlined in red on the "Plan of Part of Canteen Road as shown on L.R.O. Plan No. 10, Suburban Lots 25 and 55 Esquimalt District" made by J.R.C. Hewett and dated the 17th day of July, 1952.
2. The Reeve and the Municipal Clerk of the Corporation of the Township of Esquimalt are hereby authorized and directed to execute and deliver Deeds of Conveyance granting and conveying the said lands to Her Majesty the Queen in the Right of Canada represented by the Honourable the Minister of National Defence.
3. This By-law may be cited as the "Sale of Closed Streets By-law, 1953".
