

CORPORATION OF THE TOWNSHIP OF ESQUIMALT

BY-LAW NO. 716

BEING a By-law to authorize the sale of certain lots to Joseph Politano and Thelma Mary Politano.

WHEREAS the Corporation of the Township of Esquimalt is the registered owner of those certain parcels or tracts of land situate, lying and being within the Municipality of Esquimalt, in the Province of British Columbia, more particularly known and described as Lots Six (6), Seven (7), Eight (8), Nine (9) and Ten (10) in Block One (1) of Section Ten (10),

AND WHEREAS the said lots are not required for Municipal purposes,

AND WHEREAS by reason of the value of the said lands and by reason of the population figure according to the last decennial census for the Corporation of the Township of Esquimalt this By-law does not require the assent of the electors of the said Corporation,

AND WHEREAS an offer has been received for the sale of the said lots and it is expedient in the opinion of the Council to dispose of the said lots and to accept the said offer,

NOW THEREFORE the Municipal Council of the Corporation of the Township of Esquimalt enacts as follows:

1. It shall be lawful for the Corporation of the Township of Esquimalt to sell and convey to Joseph Politano and Thelma Mary Politano as joint tenants, both of 1205 Tillicum Road, in the Municipality of Esquimalt, in the Province of British Columbia, all those certain parcels or tracts of land situate, lying and being in the Municipality of Esquimalt, in the Province of British Columbia, and more particularly known and described as Lots Six (6), Seven (7), Eight (8), Nine (9) and Ten (10) in Block One (1) of Section Ten (10), Esquimalt District, Plan 11214, for the total price or sum of \$5,610.00 of lawful money of Canada, such sum being allocated to the purchase of the various lots as follows, that is to say: as to Lot Six (6), the sum of \$1,210.00; as to Lots Seven (7), Eight (8), Nine (9) and Ten (10), the sum of \$1,100.00 each.
2. The Reeve and the Municipal Clerk of the Corporation of the Township of Esquimalt are hereby authorized and directed to execute and deliver a Deed of Conveyance granting and conveying the said lands to the said Joseph Politano and Thelma Mary Politano, as joint tenants.
3. This By-law may be cited as the "SALE OF LOTS 6, 7, 8, 9, and 10, BLOCK 1, SECTION 10, ESQUIMALT DISTRICT, PLAN 11214 BY-LAW".
