CORPORATION OF THE TOWNSHIP OF ESQUIMALT

BY-LAW NO. 850

BEING a By-law to authorize the Corporation of the Township of Esquimalt to sell certain lands hereinafter described to The Board of School Trustees of School District No. 61 (Greater Victoria).

WHEREAS the Corporation of the Township of Esquimalt is seized in fee simple of the lands hereinafter described,

AND WHEREAS the said lands and premises are no longer required for Municipal or other public purposes and are free from any reservation or dedication under the terms of Sections 465 and 466 of the "Municipal Act".

AND WHEREAS there are no buildings or structures of any kind on the said lands and premises,

AND WHEREAS the Council of the Corporation has power to sell and dispose of the said lands by by-law,

AND WHEREAS The Board of School Trustees of School District No. 61 (Greater Victoria) has paid to the Corporation the purchase price of the said lands, in the amount of Five Thousand Dollars (\$5,000.00),

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF ESQUIMALT enacts as follows:

- 1. By-law No. 848, cited as the "School Board Land Sale By-law, 1958", is hereby repealed.
- 2. It shall be lawful for the Corporation of the Township of Esquimalt to sell, grant and convey all those certain parcels or tracts of land situate, lying and being in the Municipality of Esquimalt, in the Province of British Columbia, more particularly known and described as follows, that is to say:
 - Lots 5, 7, 8, 9, 10 and 11, Block 1, Section 10, Esquimalt District Plan 6277,
 - Lots 4, 5, 6 and 7, Block 2, Section 10, Esquimalt District Plan 6277,
 - Lot 8, Section 10, Esquimalt District Plan 1137,
 - Lots 1 and 2, Section 10, Esquimalt District Plan 2027,
 - Lots 1, 3, 4, 5, 6, 7, 8, 9, 10 and 12, Section 10, Esquimalt District Plan 1248,
 - Lots 6 and 7, Block E, Section 10, Esquimalt District Plan 195C,

On May 30 For

for the price or sum of Five Thousand Dollars (\$5,000.00) of lawful money of Canada, payable by the said The Board of School Trustees of School District No. 61 (Greater Victoria) to the Corporation in cash.

- The Reeve and the Municipal Clerk of the Corporation of the Township of Esquimalt are hereby authorized and directed to execute and deliver a Deed of Conveyance granting and conveying the said lands and premises herein described to The Board of School Trustees of School District No. 61 (Greater Victoria).
 - This By-law may be cited as the "School Board Land Sale By-law, 1959".
