# Election Day 2011: What You Need to Know

## Am I Qualified to Vote?

You are qualified to vote if you meet the following criteria:

- 18 years of age or older;
- Canadian citizen;
- Resident of British Columbia for at least six months;
- Resident of the Township of Esquimalt for at least 30 days; and
- Are not disqualified from voting by any statute or law.

Voter registration will occur at the time of voting. To vote, you will need to show at least two pieces of identification that provide evidence of your place of residence. At least one piece of ID must contain your signature.

If you are a non-resident property elector, you will need to show two pieces of identification and proof that you are the registered owner of the property. If there are two or more owners for the property, you must demonstrate, in writing, that you have the consent of the majority of the owners to vote on their behalf. A Non-resident Property Elector Consent Form is available on our website.

## How is the Esquimalt Village Plan related to the November 2011 Election ?

Council is seeking the public's opinion to determine whether the community is in favour of the Esquimalt Village Plan as proposed. The following question will appear on the November 2011 Election Ballot:

*Are you in favour of the Township of Esquimalt adopting amendments to Official Community Plan Bylaw No. 2646 and Zoning Bylaw No. 2050 that would facilitate development of Phase One of the Esquimalt Village Plan which would include a mix of residential, commercial and civic uses in two buildings, one of which may be up to 12 storeys in height, on the site of the old municipal hall and old public works yard? Yes or No?*

## Medal Winners!

### Canine Section of Vic PD Medals at World Games



Sgt. Mike Chicorelli and Police Service Dog "Max" of the Victoria Police Department - West Division

The Canine Section of the Victoria Police Department - West Division recently returned from competing in the 2011 New York World Police Fire Games. The Canine Section consists of six dogs and five handlers who operate out of the Esquimalt Public Safety Building near Municipal Hall. In addition to handling Max, a chocolate labrador, Mike Chicorelli is the officer in charge of the section, trains the other handlers and handles a second chocolate labrador "Cruise," a drug detection dog. Mike and Max competed in the explosive detection category at the recent games and won a gold medal in vehicle searches and a bronze medal in building searches. This is the second consecutive World Police Fire Games in which this team has won medals, bringing their total to five golds and one bronze, including an overall gold medal at the 2009 Vancouver World Police Fire Games. Mike and Max's considerable skills were also put to work during their deployment at the Vancouver 2010 Olympic Games.

## Considering renovations?

### Remember to contact a Township Building Inspector

If you are considering an addition to your home, a renovation that would affect load-bearing walls, enclosing space, building a deck, or installing new plumbing, you need to contact our Building Inspection department before you begin work. Our Building Inspectors will advise you whether a Building Permit is required for the work you are proposing. Renovations are subject to the same regulations as new construction and a Building Permit is required for all types of buildings, regardless of when they were built.

The purpose of building permits and inspections is to ensure that all construction work meets the requirements of the BC Building Code and Plumbing Code. The B.C. Building Code is a set of minimum provisions respecting the safety of buildings with reference to public health, fire protection and structural sufficiency. Having a record that work was done with a permit will be of value to you when you go to sell your home.

The municipality encourages owners of older buildings to maintain and improve them. However, structural alterations, additions and repairs to these buildings do require a Building Permit and, if you are altering the exterior of a designated heritage building, a Heritage Alteration Permit. The Building Code was primarily written for new construction and is not always practical for heritage buildings. There may be alternate compliance methods to allow your renovations and still achieve the performance levels intended by the Building Code.

### Business Licenses, Dog Licenses Renewal in New Year

At the end of December 2011, the Township will be mailing out renewal notices for 2012 business and dog licenses.

Residents and business owners are encouraged to renew their business licenses by January 30, 2012. After that date an additional license fee of 10% (with a minimum fee of \$25) will be applied.

A discount of \$5 applies for payments on dog licenses received by January 30, 2012.

Failure to renew a business license is an offence under the Township's Business Bylaw No. 2482, which provides for fines ranging from \$500 to \$2,000.
