5. PRESENTATIONS

1) <u>20-126</u> Victoria Police Department 2019 Fourth Quarter Report

Chief Del Manak, Victoria Police Department, provided an overview of the 2019 fourth Quarter Report, presented a PowerPoint Presentation, and together with Inspector Keith Lidner responded to questions from COTW.

COTW comments included the cost impact to Esquimalt associated with providing policing for protests occuring in downtown Victoria, recent lower Johnson Street Police Task Force initiative, and cross over calls from Esquimalt to Victoria.

Moved by Mayor Desjardins, seconded by Councillor Brame: That the Committee of the Whole recommends to Council:

- 1. That Council direct staff to draft a letter to the Victoria and Esquimalt Police Board requesting itemized separation of the costs for the Lower Johnson St policing task force and policing costs associated with the City of Victoria protests, within the budget; and
- Council That also direct staff to draft letter to Brenda а Butterworth-Carr, Assistant Deputy Minister and Director Police Services, under section 12.1 of the Framework Agreement, requesting activation of the Administrative Committee to work to resolve this dispute. Carried Unanimously.

2) 20-077 Proposed Detached Accessory Dwelling Unit (DADU) Process and Regulation, Staff Report No. DEV-20-015

Director of Development Services provided an overview of the Detached Accessory Dwelling Unit (DADU) initiative, the Planner presented a PowerPoint Presentation, and together they responded to questions from COTW.

COTW comments included consideration of parking requirements to reduce impact to street parking and options for public consultation including surveys and open houses.

Moved by Mayor Desjardins, seconded by Councillor Brame:

- 1. That the Committee of the Whole receives Staff Report No. DEV-20-015 for information and provide additional direction to staff as the Committee of the Whole considers advisable; and
- 2. That the Committee of the Whole direct staff to undertake consultation with the public as outlined in Staff Report No. DEV-20-015 prior to bringing forward zoning bylaw amendments and development permit guidelines for Council's consideration. Carried Unanimously.

Andrew Ackers, *resident*, requested COTW consider additional options for the DADU initiative to increase liveability of the detached dwelling units including allowing increased floor levels for lofts and staircases and ensuring affordability measures with building requirements and processes for homeowners.
