Esquimalt Village Plan: Imagining our Future



he Esquimalt Village Plan, with several years of planning, public comment, and Council consideration, represents a new vision for the future of Esquimalt. And the plan is moving forward in 2011 with a new focus.

In October, 2010, Council approved a preferred option for the plan, which establishes criteria for mixed-use development on the site, encompassing the old Municipal Hall and Public Works Yard and Town Square, all located in the Park Place area of Esquimalt. Building design will be contemporary and bold, using large window panels to take advantage of the harbour and distant views. Other building materials will include concrete, brick, wood, cement, and metal panels.

The site will include an eight-storey commercial mixed-use building located between Park Place and Thornton Walk, and a 12-storey residential building located east of Thornton Walk and south of the Municipal Hall. The western building will contain a mix of commercial, institutional and residential uses while the eastern building will consist of townhomes at ground level with condominiums above.

All parking required by the library and town hall — as well as the commercial, civic and residential spaces associated with this development — will be situated underground.

The three key landscape features of the plan include: 1) the relocation of Town Square to enhance the streetscape of Esquimalt Road, 2) the redevelopment of Thornton Walk to serve as the principal pedestrian connection through the Village, and 3) the development of a pedestrian greenway along the north side of Carlisle Avenue linking the Village to the Esquimalt Recreation Centre and beyond.

Although Council has supported this option of the plan, the changes to the Official Community Plan and Zoning Bylaw must be done by amending bylaws. Staff has prepared the appropriate amending bylaws and will be presenting them to Council for consideration later in the spring of 2011. Esquimalt's Centennial Memorial Walkway



ne of the planned legacy projects of the Esquimalt Centennial 2012 is to upgrade the walkways leading up to the cenotaph in 75-year-old Memorial Park. Paving stones with dedications are being offered for sale by the Centennial Committee to be placed throughout the two approaches to the cenotaph. "This is an opportunity to pay tribute to those you hold dear in your family and in your community," said Mayor Barb Desiardins, shown centre with Centennial Committee Chair Janet Jones and Vice Chair Bruce Devitt. "We hope that residents will participate in this historic project so that dedicated pavers can be in place for the centennial year."

One hundred dollars will reserve a 4"x 8" brick with 3 lines of 18 characters

per line. Two hundred dollars will reserve a large 8"x 8" brick with 4 lines of 18 characters per line. The pavers are tax deductible and the Township will be issuing receipts to purchasers.

Plan a Pesticide-Free Lawn & Garden

On the 14th of July, 2008, Esquimalt Council adopted Bylaw No. 2686 to ban the use of non-essential pesticides on residential properties within the community.

The use of these chemical pesticides carries health, safety and environmental risks and Esquimalt has joined the growing trend towards a more environmentally sensitive approach to pest management.

"Maintaining healthy ecosystems, as well as attractive parks and greenways, is our goal. We think residents share this goal when maintaining their lawns and gardens," said Katschor.

According to the Canadian Cancer Society, exposure to pesticides has been linked to both childhood and adult cancers. Since the application of non-essential pesticides has no health benefit and has the potential to cause harm, the Canadian Cancer Society endorses the use of the precautionary principle, and supports banning their use (more information can be found at www.cancer.ca).

"Esquimalt showed a strong commitment to public health and the environment in passing their pesticide use bylaw in 2008", says Nancy Falconer, Health Promotion Coordinator with the Canadian Cancer Society. "We definitely encourage residents to explore alternatives, and take advantage of the wealth of tools and resources now available to assist homeowners."

Township Requests Proposals for Policing Services

At a news conference on March 4th, 2011 Mayor Barb Desjardins outlined the findings of the Esquimalt Policing and Law Enforcement Advisory Panel and the next steps for the Township's vision of community policing. The Township has issued a Request for Proposals for the Provision of Policing Services to the City of Victoria, the District of Saanich and the RCMP. The RFP comes after several months of work by the Advisory Panel to gather public input and conduct research on Township policing options.

"We value the work that VicPD has done for this community and we continue to value our police officers," said Mayor Desjardins. "But our residents have spoken and they have told us they want community-based decision-making around policing, the best possible policing for their tax dollars, and a dedicated patrol based in the municipality. Mayor Desjardins added that Council is also unanimous in its support of the process to explore options in the delivery of police services to the community.

The Panel will submit a report to the Solicitor General in the coming months that makes recommendations on alternative service delivery models. **More information:** www.esquimalt.ca/publicSafety/policeDepartment/policeBoard

Secondary Suites Update

Free Legalization for Secondary Suites Ending Soon

April 24th, 2011 is the last day to apply for a free building permit to legalize a secondary suite. Applications submitted by this date will receive free inspections and registration for this year.

If you have a suite, this is a great opportunity to protect yourself from possible liability. As a landlord, if your property does not meet minimum safety standards you could be found liable by the courts and lose your insurance coverage for damages caused or injuries sustained by your tenant.

The BC Building Code was enacted to establish minimum standards for buildings and contains a section specifically for secondary suites. Esquimalt's Building Officials are available to assist home owners in finding ways to meet the standards set by the BC Building Code.
