<b>Who Is Eligible?</b>	Residents of Esquimalt whose combined gross household income is below the Statistics Canada Low Income thresholds (range on reverse). Applications must be processed locally (Esquimalt Recreation Centre), after which the 52 Drop-in Admissions may be used at any Municipal Recreation Centre in Greater Victoria. The annual pass option and the 52 Esquimalt Drop-in Admissions and program discounts are restricted to use at the Esquimalt Recreation Centre.
<b>How Do I Apply?</b>	<ul style="list-style-type: none"> <li>• Complete one application per household and drop it off with the reception staff at the Esquimalt Recreation Centre, 527 Fraser St, Victoria BC, 250-412-8500.</li> <li>• <b>Bring current identification such as Care Card, BC ID, Drivers License.</b></li> <li>• <b>Bring current proof of residency, such as a utility bill or rental agreement.</b></li> <li>• <b>Bring proof of your gross annual household income, in the form of your 2018 or 2019 <u>Notice of Assessment</u> from Revenue Canada.</b> To obtain a Notice of Assessment call 1-800-959-8281.</li> <li>• L.I.F.E. cards will be issued to each member in each eligible household.</li> <li>• L.I.F.E. cards are valid until Dec 31, 2020.</li> <li>• Your L.I.F.E. application will be processed within 3 business days.</li> </ul>
