# 1. CALL TO ORDER

The meeting was called to order at 7:00 p.m.

### 2. LATE ITEMS

### 3. APPROVAL OF THE AGENDA

Moved by Councillor Sterk, seconded by Councillor Linge that the agenda be approved as amended. The motion **CARRIED**.

Moved by Councillor Sterk seconded by Councillor Hundleby that the Minutes of the Joint Meeting of Parks and Recreation Commission, Cultural Advisory Committee and Economic Development Advisory Committee, June 30, 2008, Minutes of the Regular Meeting of Council, July 7, 2008, and Minutes of the Special Meeting of Council, July 14, 2008 be adopted. The motion **CARRIED**.

# 5. PUBLIC INPUT (On items listed on the Agenda)

Excluding items which are or have been the subject of a Public Hearing.

#### (1) Alison Gaul, Grenville Avenue

Ms. Gaul supports having a raised sidewalk between the Sports Centre and Esquimalt Plaza. She expressed concern that the sidewalk will be using funds dedicated to the Archie Browning Sports Centre and that public perception is that these funds should be used for the Sports Centre and not for upgrading.

### (2) Steven Roberts, 1132 Craigflower Road

Mr. Roberts spoke in support of the Bylaw to implement Parking Permits on Craigflower Road as there is a problem with parking. He likes the idea of having two permits per household. He expressed concern regarding how this Bylaw would be enforced.

### 6. DELEGATION

### (1) Doubravka B. Spilka, Re: Zebra Crossing on Old Esquimalt Road and Bylaw Making Esquimalt Plaza Smoke Free

Ms. Spilka spoke about installing a "zebra crossing" on Old Esquimalt Road which she had mentioned several years ago as it is very dangerous to cross the road at Highrock Park. She asked for recognition of the problem and for Council to deal with the traffic issue. Also suggested was that signs warning of the crossing be installed in both directions.

Ms. Spilka also mentioned her concern with people smoking around Country Grocer in the Esquimalt Plaza. She suggested that the smoking is driving people away and that the Plaza should be smoke free.

The Director of Engineering and Public Works noted that there has been extensive public consultation with the neighbourhood regarding Old Esquimalt Road and believes that actions already implemented and playground signs placed on both sides of the crosswalk will alleviate safety concerns.

Mayor Clement noted that he would approach the Plaza owners with Ms. Spilka's concerns.

### (2) Najib Asfar, Re: Elimination of Bus Stop on Southwest Side of Admirals Road and Landscaping Improvements for Admirals Road / Esquimalt Road Intersection

Mr. Asfar is landscaping a residential building on Admirals Road and has requested that one of the BC Transit bus stops be removed or moved as it is located in front of his building.

Mayor Clement suggested that he work with the Director of Development Services and the Director of Engineering and Public Works.

#### (3) C. Joe Richards, Re: Proclamation Request for Anniversary of First passenger Train from Esquimalt to Nanaimo and Esquimalt Parks

Mr. Richards suggested a proclamation for September 30<sup>th</sup> to

celebrate the 122<sup>nd</sup> Anniversary of the first passenger train from Esquimalt to Nanaimo. He noted that several years ago Council was going to do something about the railway stop at Admirals and Colville road. Mr. Richards gave Mayor Clement a copy of the Esquimalt & Nanaimo Railway schedule from 1939.

He also spoke about a petition he is circulating to have the name of Colville Park changed to Boulton Park in honour of Councillor Basil Boulton who passed away in January of this year.

Mayor Clement noted that he would support the petition to have the park renamed.

# (4) Kim Bellefontaine, Re: Sewage Treatment and Integrated Resource Management

Ms. Carole Witter read a letter on behalf of Kim Bellefontaine regarding sewage treatment and advancing opportunities for Integrated Resource Management. The Sewage Treatment Action Group (STAG) requests the support of Mayor and Council to pursue Integrated Resource Management opportunities.

Mayor Clement noted that as Chair of the Core Area Liquid Waste he will support Integrated Resource Management and will also set up a meeting with STAG.

### (5) Robert Buckle, Re: Animal Bylaw to Allow Urban Hens – Bylaw 2495

Mr. Buckle expressed concern with the location of structures and cages as it has created a problem in his neighbourhood. He suggested that the guidelines in the Bylaw be changed to include options on the location of structures.

Mayor Clement suggested considering amending the Bylaw to include this information.

# 7. STAFF REPORTS

# Parks and Recreation

# (1) Release of Funds to Address Unexpected Sports Centre Needs, Staff Report No. P&R-08-013

The Director of Parks and Recreation reported on the two unexpected needs for the operation of Archie Browning Sports Centre. She commented that she has worked with the owner of the Plaza to come up with the solution of a raised sidewalk between the Sports Centre and Esquimalt Plaza.

Comments from Council include:

• Concerns that funds are coming out of Archie Browning

Sports Centre money and not Public Works funds.

The Director of Financial Services noted that it is not recommended to take the funds for this work from Contingency funds at this time.

Moved by Councillor Freedman, seconded by Councillor Sterk that Council approve the release of \$14,000 from the funds specified for Archie Browning Sports Centre within the Capital Projects Reserve Fund to address two unexpected Sports Centre needs:

- 1. The replacement of a Food Services dishwasher
- 2. The installation of a raised sidewalk between the Sports Centre and the Esquimalt Plaza.

The motion **CARRIED**.

Councillor Desjardins **OPPOSED.** 

# Finance

### (2) Local Grants – Esquimalt Community School, Staff Report No. FIN-08-010

The Director of Financial Services noted that the revision to Policy Admin is to be consistent with what is accepted and regular practice. She advised that she will bring forward the proposal to specify funds for L'Ecole Brodeur at 2009 local grant discussions.

Moved by Councillor Hundleby, seconded by Councillor Sterk that Council adopt the revision to Policy Admin – 29 to reflect current and historical practice of allocating \$3,000 for Esquimalt High student athletic team travel costs. The motion **CARRIED**.

#### (3) Local Grant Application, Staff Report No. FIN-08-011

Moved by Councillor Sterk, seconded by Councillor Linge that Council approve the Local Grant Application from Big Brothers Big Sisters of Victoria for the full amount requested of \$7,503. The motion **CARRIED**. Councillor Hundleby **OPPOSED**.

#### **Development Services**

#### (4) Amendment to Animal Bylaw to Allow Urban Hens, Staff Report No. DEV-08-077

Moved by Councillor Sterk, seconded by Councillor Desjardins that Third Reading of Bylaw 2692 be rescinded and Adoption of Bylaw be tabled until staff review the Bylaw and provide more options to allow the keeping of urban hens. The motion **CARRIED**.

# **Engineering and Public Works**

#### (5) Residential Parking Permits on Craigflower Road and Sioux Place, Staff Report No. EPW-08-029

The Director of Public Works and Engineering noted that some residents on Craigflower Road have a large number of cars and several options have been reviewed to deal with this issue. Issuing Residential Parking Permits would be a temporary measure until Craigflower Road is upgraded next year. The long term plan is to maintain parking permits on the North side of the street.

Comments from Council include:

- Concerns with safety for cyclists.
- Part of the reason for street parking is that tenants do not want to pay for parking in their building.
- It is not up to the municipality to provide residential parking.

Moved by Councillor Desjardins, seconded by Councillor Linge that Council authorize staff to amend the Streets and Traffic Control Bylaw to allow the establishment of Residential Parking Permit Zone on a portion of a street. Following the adoption of the amendment, two traffic orders would be issued. One traffic order to implement a Residential Parking Permit Zone on Sioux Place and the north side of Craigflower Road between Sioux Place and house no. 1102. The other would be to repeal Traffic Order No. 1137 which bans daytime parking on the south side of Craigflower Road.

The motion CARRIED.

Councillor Sterk **OPPOSED.** 

Moved by Councillor Desjardins, seconded by Councillor Hundleby to amend the motion by deleting the last sentence "The other would be to repeal Traffic Order No. 1137 which bans daytime parking on the south side of Craigflower Road". The motion **CARRIED.** 

#### (6) Old Esquimalt Road – Dominion Road to Head Street, Staff Report No. EPW-08-030

The Director of Public Works and Engineering advised of the installation of a three-way stop at the intersection of Old Esquimalt Road and Aldebury Street. This is an interim measure to address speeding on Old Esquimalt Road. Traffic counts will be done in the Fall to identify the success of the three-way stop. Signs will be posted informing the public about the traffic change.

Comments from Council include:

- Speeding is an issue.
- How will this information to install the stop be relayed to the public?
- Previous information stated that enforcement was going to be increased in the area. Suggestion to request report from Inspector Sylven regarding how often enforcement is carried out.
- Concerns with enforcement and that Esquimalt is under served by the Police.
- Concern that this measure may increase accidents.

Moved by Councillor Linge, seconded by Councillor Sterk that Council approve Traffic order No. 1155 for the installation of three-way stop at the intersection of Old Esquimalt Road and Aldebury street. This three-way stop is considered to be an interim measure until a more detailed traffic study and public consultation process is carried out to determine if other traffic calming measures would be appropriate for the section of Old Esquimalt Road between Dominion Road and Head Street. The motion **CARRIED**.

# (7) Various Parking Issues, Staff Report No. EPW-08-031

Moved by Councillor Sterk, seconded by Councillor Hundleby that Council approve the following Traffic Orders (TO):

- 1. TO # 1151 no parking on the east side of Admirals Road for a distance of 21 metres south of Woodway Road.
- TO # 1152 No parking on the west side of Admirals Road for a distance of 7 m north of the driveway into 883 Admirals Road.
- 3. TO # 1153 No parking on the south side of Devonshire Road for a distance of 21 metres west of Porter Road and a distance of 10 metres east of Porter Road.
- 4. TO # 1154 No parking on the east side of Dellwood Road for a distance of 11 metres north of Craigflower Road and on the west side of Dellwood Road for a distance of 10 metres north of Craigflower Road.

The motion **CARRIED.** 

(8) CRD Bylaw 3150 – Climate Action and Adaptation Service Establishment Bylaw, Staff Report No. EPW-08-032

Comments from Council include:

• Concerns with new clause" withdrawal of services" and that all supporting municipalities would have to pick up the cost.

Moved by Councillor Sterk, seconded by Councillor Hundleby that the Township of Esquimalt give consent to the Capital Regional District for the adoption of the revised CRD Bylaw No. 3150, *Capital Regional District Action and Adaptation Service Establishment Bylaw, 2008* in accordance with Section 801.4 of the Local Government Act. The motion **CARRIED**. Councillor Freedman **OPPOSED**.

# (9) Yard and Garden Waste Drop-Off Facility, Staff Report No. EPW-08-033

Moved by Councillor Desjardins, seconded by Councillor Hundleby that Yard and Garden Waste Drop-Off Facility, Staff Report No. EPW-08-033 be received for information. The motion **CARRIED**.
