# 1. CALL TO ORDER

Acting Mayor Brame called the meeting to order at 7:00 p.m.

# 2. LATE ITEMS

There were no late items.

#### 3. APPROVAL OF THE AGENDA

<u>Moved</u> by Councillor Hundleby, seconded by Councillor Garrison that the Agenda be approved as presented. The motion **CARRIED**.

### 4. MINUTES

(1) Minutes of the Regular Meeting of Council, August 17, 2009

One change was noted:

P. 3: "Esquimalt can expect 2 police cars" should read <u>West Division</u> can expect 2 police cars.

<u>Moved</u> by Councillor Linge, seconded by Councillor McIldoon that the Minutes of the Regular Meeting of Council, August 17, 2009 be adopted as amended.

#### 6. STAFF REPORTS

Administration

(1) Authority to issue Traffic Orders, Staff Report No. ADM-09-044

<u>Moved</u> by Councillor Linge, seconded by Councillor Hundleby that under Streets and Traffic Bylaw No. 2607, 2005, the Director of Development Services be authorized to execute Traffic Orders in the absence of a Director of Engineering and Public Works. The motion **CARRIED.** 

# Engineering and Public Works

(2) Craigflower Road Traffic Orders, Staff Report No. EPW-09-035

I/Chief Administrative Officer Laurie Hurst advised that as a result of the two phases of road improvements for Craigflower Road, 26 Traffic Orders were combined into 3 standing orders to conform to the improved road design layout. She added the Traffic Orders conformed to the maps of the redesigned Craigflower Road displayed at the public Open Houses.

In response to Council's concern that the public be informed of immediate changes in residential parking regulations, Ms. Hurst noted she would work with Bylaw Enforcement on a grace period to allow the public time to adjust to the new restrictions.

<u>Moved</u> by Councillor Linge, seconded by Councillor Hundleby that

- 1. Council approve the following Traffic Orders (TO):
  - TO No. 1172 No Parking and No Stopping, Tow Away Zone on Craigflower Road between the East boundary and Garthland Road excluding three designated parking zones:
  - TO No. 1173 No Parking and No Stopping, Tow Away Zone on south side of Craigflower Service Roads; North side of Craigflower Service Road for 20 metres in front of 1060 Craigflower Road and for 20 metres in front of 1144 Craigflower Road;
  - TO No. 1174 Various Bus Stops on Craigflower Road; and
- 2. That Council repeal the 26 Traffic Orders as follows:

(3) Amendment to Streets and Traffic Regulation Bylaw, 2005, No. 2607, Staff Report No. EPW-09-037

I/Chief Administrative Officer Laurie Hurst advised that the amendments to the speed zones are recommended by the former Director of Engineering and Public Works in consultation with the Inspector of West Division, Vic PD. The effect of the amendments will reduce the speed limit to 30 km/hr along sections of Old Esquimalt Road, Selkirk Avenue, Lockley Road and Colville Road, and provide consistent speed zones and improve safety in those areas. Ms. Hurst will pass on Council's comments to Vic PD to increase traffic enforcement in the

reduced speed zone areas until drivers become familiar with the new speed, and to give consideration to install speed strips as an additional reminder to reduce speed.

<u>Moved</u> by Councillor Garrison, seconded by Councillor Hundleby,

- 1. That the *Streets and Traffic Regulation Bylaw, 2005, No. 2607* be amended as follows:
  - Reducing the speed limit to 30 km/hr on Old Esquimalt Road from Dominion Road to Lampson Street:
  - Reducing the speed limit to 30 km/hr on Selkirk Avenue from Tillicum Road to Arm Street;
  - Reducing the speed limit to 30 km/hr on Lockley Road;
  - Reducing the speed limit to 40 km/hr on Colville Road between Lampson Street and Admirals Road
- 2. That Streets and Traffic Regulation Bylaw 2005, No. 2607, Amendment Bylaw [No. 5], 2007, No. 2716 be given first, second and third reading as amended.

The motion **CARRIED**.

#### Fire Services

(4) Consent and Indemnity Agreement – First Responder Program, Staff Report No. FIRE-09-006

Deputy Fire Chief Anderson advised that the First Responder Agreement gives legal authority to the Esquimalt Fire Rescue to continue to provide the community First Responder Services under the *Emergency and Health Services Act.* He added the Agreement is acceptable to the Fire Chiefs Association of BC, Union of BC Municipalities and the Municipal Insurance Association.

Moved by Councillor Hundleby, seconded by Councillor Gaul that the Mayor and Corporate Administrator be authorized to execute the "First Responder Agreement (Consent and Indemnity)" between the Emergency Health Services Commission and Esquimalt Fire Rescue.

The motion **CARRIED**.

#### Development Services

(5) Amendment to Appendix A, Schedule of Fees to Building Bylaw No. 2538, Staff Report No. DEV-09-047

Director of Development Services Barb Snyder advised that the proposed fee schedule amendments would increase 1997 rates to more closely align with cost of services today. The change to

the test, clear and capping fees simplifies the process for the property owner and ensures that work done by others meets municipal safety standards.

<u>Moved</u> by Councillor Linge, seconded by Councillor Hundleby that Council repeal the existing Fee Schedule, "Appendix A", to Building Code Bylaw, 2002, No. 2538, and replace it with a new "Appendix A", as attached, and that Bylaw No. 2711 be given first, second and third readings.

The motion CARRIED.
