# 1. CALL TO ORDER

Mayor Designations called the meeting to order at 7:00 p.m.

#### 2. LATE ITEMS

**MOTION:** That the Minutes of the Regular Meeting of Council, May 16, 2011 be approved as circulated. MOVED/SECONDED. Councillor Hundleby/Councillor Linge. **CARRIED UNANIMOUSLY**.

# 5. PRESENTATIONS

(1) Marlene Lagoa, Capital Regional District EcoStar Awards

Ms. Lagoa introduced the winner of the Capital Regional District EcoStar Award for Community Environmental Leader, Mr. Mark F. Salter. A CRD promotional video was presented which highlighted Mr. Salter's leadership in establishing the first community garden in Esquimalt.

Mayor Desjardins welcomed Mr. Salter to come forward and speak to

Council. Mr. Salter thanked Mayor, Council and Staff for their support and gave a short overview of future plans to expand community gardens in the municipality.

#### 6. PUBLIC INPUT

Mayor Desjardins informed the public that input with regards to the Esquimalt Village Project Bylaw Amendments, which have been the subject of a Public Hearing, cannot be raised during this public input period.

*Muriel Dunn, 1193 Old Esquimalt Road,* asked whether the decision to demolish the Old Municipal Hall could be postponed until more information was available on the Esquimalt Village Project.

Don Dashney, 1142 Lockley Road, raised his concerns about the blind corner on Lockely Road when turning left onto Admirals Road as well as speeding that occurs on Lockley from motorists that are avoiding the new intersection at Admirals and Colville Road. Mr. Dashney suggested that the shrubs be trimmed back in order to improve visibility at the corner.

Chris Moerike, President of the Esquimalt Baseball Association, thanked the Mayor, Council and the Township of Esquimalt for their continued support and referred to the presentation of the Citizen's award to Tony Bendall and Esquimalt Park's Turf and Tree Crew as well as a signed baseball to Mayor Desjardins.

Terry Prentice, 1297 Rockcrest Avenue, noted that previous councils agreed on the unsatisfactory condition of the old Municipal Hall and that it cannot be renovated. Mr. Prentice reminded Council that it already made a decision to demolish the building when it placed a call for tenders. Mr. Prentice urged Council to unanimously vote to proceed with the demolition.

Dale Wood, 1174 Greenwood Avenue, commented on Staff Report No. ADM-11-036, Esquimalt Village Project – Amendments to OCP and Zoning Bylaws. Mr. Wood referred Council to the motion that discussion on the bylaw amendments be postponed indefinitely and that it was carried unanimously. Mr. Wood noted that parliamentary procedure indicated that in such a case the whole process would have to start over. Mr. Wood stated that Council is compromising the process.

Paul Gilbert, 520 Comerford Street, indicated that the issues of the demolition of the old Municipal Hall and the Esquimalt Village Project cannot be separated. Mayor Desjardins reminded the speaker that public input on the Esquimalt Village Project can not be heard.

#### 7. DELEGATIONS

(1) Peter Such, Victoria College of Art, Alternatives to Demolition of Old Municipal Hall and Suggest Economically Viable Restoration Strategies

Mr. Such proposed to Council that they partner with the Victoria College of Art to preserve and renovate the Old Municipal Hall. Mr. Such noted that 10 years earlier the College and municipality were in negotiations for the College to use the building.

Mr. Such indicated he would acquire funding to reconstruct the building in addition to the College offering an educational program which will allow 300 students to work on the project. Mr. Such reminded Council that the Old Municipal Hall will be a lost to future generations should the building be demolished.

(2) Colin MacLock, Reasons to Save the Only Municipally Owned Heritage Building – The Old Town Hall

Mr. MacLock stated that culture and heritage goes hand in hand. He noted that he took up the challenge of bringing new industry into Esquimalt 12 years ago, which had been the arts, and that it is still ongoing. Mr. MacLock reminded Council that the restoration of the Old Municipal Hall would be of no cost to the Municipality and that they should not reject the Victoria College of Art's offer.

Development Services

Council discussion ensued on the state of the Old Municipal Hall site, the importance of heritage and the costs associated with upgrading the site. It was noted that input from the public on preserving the building only surfaced late in the process.

Hall Site, Staff Report No. DEV-11-048. MOVED/SECONDED. Councillor Brame/Councillor Hundleby. CARRIED (Mayor Desjardins, Councillors Hundleby, Gaul, Linge and Brame in favour; Councillor McIldoon opposed).

Engineering and Public Works

(2) Tender Recommendations for Municipal Structures
Deconstruction Project, Staff Report No. EPW-11-015

Council discussion ensued on the process of removing the Old Municipal Hall from the demolition tender, the municipality's responsibility to remediate the brownfield site, uncertainty that funding will be available for renovations and the cost of the Old Municipal Hall building remaining empty.

**MOTION:** To cancel the Deconstruction Project Tender and delay the Project until 2012. MOVED/SECONDED. Councillor Hundleby/Councillor Gaul. **DEFEATED** (Councillors Gaul, McIldoon and Hundleby in favour; Mayor Desjardins, Councillors Linge and Brame opposed).

#### MOTION:

- That Council award the contract for the Municipal Structures Deconstruction Project to H.L. Demolition and Waste Management Ltd. at cost of \$346,848.00 (not including HST); and
- 2. That Council approves the implementation of Option 1 with the additional funds being received from the Capital Project Reserve. MOVED/SECONDED. Councillor Brame/Councillor Linge.

**MOTION:** To postpone the recommendation before Council to the next meeting. MOVED/SECONDED. Councillor Gaul/Councillor McIldoon. **DEFEATED** (Councillors Hundleby, Gaul and McIldoon in favour; Mayor Desjardins, Councillors Linge and Brame opposed).

Mayor Desjardins called a vote on the main motion.

**CARRIED** (Mayor Desjardins, Councillors Hundleby, Linge and Brame in favour; Councillors Gaul and McIldoon opposed).

**RECESS** Council took a short recess at 8:45 p.m.

**RECONVENE** Council reconvened the meeting at 8:55 p.m.

Council discussion ensued on the motion of May 16, 2011 to indefinitely postpone discussions on the amendments to the Official Community Plan Bylaw, 2006 No. 2646 and Zoning Bylaw, 1992, No 2050. Staff provided clarification on parliamentary and public hearing procedures.

Councillor Linge stated that the original intention of the motion was to allow any future Council to bring forward a new public hearing based on the material originally submitted, including information from the first public hearing, before making a decision.

Council members expressed a desire to be able to receive more information from the public on the Esquimalt Village Project bylaw amendments.

**MOTION:** That staff bring back a report with appropriate wording for a referendum question regarding the Esquimalt Village Project. MOVED/SECONDED. Councillor Brame/Councillor Gaul. **CARRIED** (Councillors Hundleby, Linge, Gaul, Brame and McIldoon in favour; Mayor Desjardins opposed).

**MOTION:** That staff prepare a report regarding the proper process for Council to allow them to receive further input on the Esquimalt Village Plan bylaw amendments until a decision is made and implications that holding a referendum has on the public input process. MOVED/SECONDED. Councillor Gaul/Councillor Brame. **CARRIED UNANIMOUSLY**
