# 1. CALL TO ORDER

Mayor Desjardins called the meeting to order at 7:01 p.m.

# 3. APPROVAL OF THE AGENDA

# 4. PRESENTATION

Mayor Desjardins presented retiring Inspector Darrell McLean, Victoria Police, West Division with a Certificate of Appreciation in recognition of his many years as Officer in Charge.

# 5. PUBLIC INPUT

*Muriel Dunn, resident* requested clarification of costs of decorative banner poles and expressed her concern that only five banner poles are to be erected.

*Judy Morton, resident* advised that with respect to the upcoming bylaw regarding feeding of squirrels, she had created a map showing where the squirrels were coming from and where they were going, and submitted the map to Council for staff.

*Dave Hodgins, resident* expressed concern with one sign on Craigflower Road that was not noticeable by the crosswalk. He suggested that the location of the "entering/leaving Esquimalt" sign should be studied.

Kelly Bryant, resident expressed concern for the safety of children in school zones because of speeding vehicles and parents parking on yellow line when picking up their children. He stated that he would put his concerns in a letter to Council, and suggested that the municipality work with the Police Liaison Officer at the school to educate children on road safety.

Bruce Cuthbert, on behalf of Esquimalt Residents Association and Esquimalt Chamber of Commerce, advised of an All Candidates meeting organized for November 9, 2011. ## HEARING STAFF REPORT

 Development Variance Permit, 472/474 Nelson Street, [Strata Lot 1, Suburban Lot 48, Esquimalt District, Strata Plan VIS1031], [Strata Lot 2, Suburban Lot 48, Esquimalt District, Strata Plan VIS1031], Staff Report No. DEV-11-079

**MOTION:** That the application for a Development Variance Permit authorizing the construction of a new deck as detailed in the plans submitted with the application stamped 'Received June 24, 2011' and sited as shown on the survey provided by Richard J. Wey & Associates stamped 'Received June 24, 2011', including the following variances, be **approved, issued and registered** on the titles of Strata Lot 1, Suburban Lot 48, Esquimalt District, Strata Plan VIS1031 [472 Nelson Street] and Strata Lot 2, Suburban Lot 48, Esquimalt District, Strata Plan VIS1031 [474 Nelson Street]:

**Zoning Bylaw 1992, No. 2050, Section 38(8)(a)** – <u>Lot Coverage</u> – a 7% increase to the requirement that all Principal Buildings, Accessory Buildings and Structures combined shall not cover more than 30% of the Area of a Parcel [i.e. from 30% to 37%];

**Zoning Bylaw 1992, No. 2050, Section 38(9)(a)(i) – <u>Front Setback</u> – a 3.3 metre relaxation to the requirement that no Principal Building shall be located within 7.5 metres of a Front Lot Line [i.e. from 7.5 metres to 4.2 metres].**

(3) Regulations Regarding the Feeding of Squirrels and Deer, Staff Report No. DEV-11-085

**MOTION:** That Bylaw No. 2779 to amend the <u>Maintenance of Property</u> <u>Bylaw No. 2180</u> to prohibit the feeding of squirrels or deer **be given** 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> readings;

That Bylaw No. 2780 to amend the <u>Ticket Information Utilization Bylaw</u> <u>No. 2619</u> to authorize tickets to be issued and establish a fine for the feeding of squirrels or deer **be given 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> readings**; and That both amending Bylaw No. 2779 and Bylaw No. 2780 not be considered for final reading and adoption until authorization has been given by the Province as required. MOVED/SECONDED: Councillor Brame / Councillor Hundleby **CARRIED UNANIMOUSLY**.

(4) Rezoning Application and Development Permit, 856 Esquimalt Road, [Lot A, Section 11, Esquimalt District, Plan VIP80973] and 858 Esquimalt Road, [Lot 2, Section 11, Esquimalt District, Plan 23904], Staff Report No. DEV-11-086

The applicant made a presentation outlining the revisions to the Development Permit application for 856 and 858 Esquimalt Road, noting that he had retained the character and form of the development.

Council had concerns about traffic calming, pedestrian safety,

landscaping and the lack of a neighbourhood pub which were addressed by the applicant.

## **MOTION:**

That Council **rescind 1<sup>st</sup> and 2<sup>nd</sup> reading** of Zoning Bylaw, 1992, No. 2050, Amendment Bylaw [No. 205], 2011, No. 2772 **approved August 15th, 2011**. MOVED/SECONDED: Councillor Linge / Councillor Hundleby. **CARRIED UNANIMOUSLY.** 

#### **MOTION:**

- That amended Zoning Bylaw, 1992, No. 2050, Amendment Bylaw [No. 205], 2011, No. 2772 which provides for changes to the zoning of Lot A, Section 11, Esquimalt District, Plan VIP80973 [856 Esquimalt Road] and Lot 2, Section 11, Esquimalt District, Plan 23904 [858 Esquimalt Road] shown cross-hatched on Schedule 'A', attached hereto, from C-6 [Licensed Liquor Establishment] and C-2 [Neighbour-hood Commercial] respectively to CD No. 80 [Comprehensive Development District No. 80], be given 1st and 2<sup>nd</sup> readings;
- 2. That a Public Hearing be scheduled;
- 3. That prior to a Public Hearing, a draft Development Permit limiting the form and character of the proposed development to that shown on architectural plans provided by Douglas P. J. Millar Architect, the landscape plan prepared by Eckford and Associates Landscape Architecture, and the survey plan prepared by Richard J. Wey and Associates Land Surveyors Inc., all of which are stamped "Received October 5, 2011", be returned to Council for consideration; and
- 4. That, prior to the public hearing, a Development Agreement or Memorandum of Understanding be prepared to ensure that the developer assumes responsibility for the costs for the off-site works on Esquimalt Road, lost infrastructure in Esquimalt Road, and the provision of new landscaping or hardscaping in the vicinity of the development as identified in the Engineering department's comments.

MOVED/SECONDED: Councillor Brame / Councillor Hundleby CARRIED UNANIMOUSLY.

**MOTION:** That Council Remuneration Bylaw, 2011, No. 2778 **be adopted.** MOVED/SECONDED: Councillor Brame / Councillor Gaul (Mayor Desjardins, Councillors Brame, Linge and Gaul in favour; Councillor Hundleby opposed). **CARRIED.**

## 13. PUBLIC QUESTION AND COMMENT PERIOD

*Tim Morrison, resident* inquired whether Council would rise and report on discussions In Camera on issues of policing services in Esquimalt.

Mayor Desjardins advised that Council has not completed their In Camera discussions.

*Terry Prentice, resident* suggested that in an effort for a more "open government" in building trust and transparency within the community, that Council respond quickly to questions regarding issues of policing services in Esquimalt.

*Rodney Laverne, resident* inquired as to how long Council was going to discuss policing.

Mayor Desjardins reported that Council was reviewing the Police Advisory Panel's recommendations and adhering to the process initiated by the Solicitor General.

*Dave Hodgins, resident* requested that more information be made available regarding the police services issues as there are a lot of questions in the community and mixed messages from the Province, City of Victoria and the Township of Esquimalt.

*Terry Prentice, resident* inquired about the staff report on feeding of squirrels and deer that suggested the bylaw refer to "household" (not person) and why this was a problem.

The Chief Administrative Officer advised that the municipality cannot prosecute a "household" and can only charge a "person".

*Diane Kleinman, resident* inquired if the bylaw requires that the municipality actually has to see someone feeding squirrels in order to charge them, and pointed out that the bylaw would be very difficult to enforce.

Mayor Desjardins stated that it was hoped that the bylaw would provide a message and a standard, and make residents aware that feeding squirrels and deer is not healthy for the community.

*Muriel Dunn, resident* reiterated her previous concern about costs for decorative banner poles and suggested a new report on the matter.

Mayor Desjardins advised that Council had a thorough discussion on the matter and have made a decision on the decorative banner poles.
