Kelly Bryant, resident, brought Council's attention to the traffic and safety issues along Lyall and Lampson Streets and requested the Township's participation in a stakeholders' meeting to be scheduled.

#### 7. HEARING

# (1) HEARING - DEVELOPMENT VARIANCE PERMIT [601/605 CANTEEN ROAD]

The Director of Development Services presented an overview of the proposed development and introduced the applicant to speak to the application.

#### **PUBLIC INPUT**

Mayor Desjardins called for public input three times and there was none.

#### ADJOURNMENT OF HEARING

Mayor Designations declared the Hearing closed at 7:40 p.m.

Councillor Linge declared a conflict of interest with the upcoming Agenda item and left the meeting at 7:41 p.m.

# (2) HEARING - DEVELOPMENT PERMIT [521 - 529 COMERFORD STREET]

The Director of Development Services presented an overview of the proposed development and introduced the applicant to speak to the Development Permit application. The applicant outlined the changes made to his application, including a Car Share option and transit passes for all units, and secure bicycle and scooter parking. The applicant's architect gave an overview of the proposed development, noting that the parking included two visitor parking spaces, two commercial parking spaces and sixteen parking spaces available to residents of the building, two of which were fully accessible.

#### **PUBLIC INPUT**

Alexandra Innes, resident inquired as to what provisions had been made for washer in every suite, pertaining to the plumbing for wash water.

Kevin Youck, resident, stated that he was not supportive of the variances requested as he was concerned about on-street parking. He submitted a Petition signed by his neighbours who were concerned about the development proposal.

*Gina Sundberg, resident*, expressed her excitement and support for the proposed development, and suggested residential parking signs on the adjacent streets.

Emmy Labonté, resident, stated that she liked the design of the proposed building, including the underground parking, and noted

that the developer has addressed all concerns raised. She pointed out that this development was well-placed to encourage people "out of their cars".

Pete Hartman, resident, stated that he was not in support of this development proposal because of the reduction in required parking requirements – from 51 to 18 parking spaces. He added that on-street parking cannot be accommodated for this development.

Maureen Sherlock, resident, stated that she liked the design of the building but was concerned about the parking variance requested. She was not in favour of the variance, noting that it did not address the number of visitors that may attend this building.

*Muriel Dunn, resident,* noted that some streets have no parking on one side of the street. She expressed her appreciation for the design of the building and the Car Share program.

Janet Jones, resident, stated that she liked the idea of a Car Share program but noted that on-street parking was an ongoing issue in the community.

Loyd Houston, resident, expressed his appreciation for the design and layout of the building. He questioned the "best use" of the property, with the fire hall and police station adjacent. He commended the developer for his plan for transit passes and the Car Share program however when the passes expired, and with visitors, it would be difficult to find parking.

Mayor Desjardins called for additional public input three times and there was no additional input.

# (1) PUBLIC HEARING - OCP AMENDMENT AND REZONING APPLICATION [1037/1039 LYALL STREET]

The Director of Development Services gave a brief overview of the proposed amendments. The applicant's planning consultant introduced others in attendance including the architect, representatives from CMHA and MacAulay Lodge who were available to answer any questions.

#### PUBLIC INPUT

Emmy Labonté, resident, expressed her support for the development proposal.

Sandra Dixon, resident, expressed concern for the existing houses on the site and for the people who currently live there.

David Bird, resident, stated that he lived directly behind the subject property and was concerned about the height of the building and its impact on his views.

Mayor Desjardins called for additional public input three times and there was no additional input.

#### ADJOURNMENT OF HEARING

Mayor Designations declared the Public Hearing closed at 8:33 p.m.

Councillor Gaul rejoined the meeting at 8:33 p.m.

# (2) PUBLIC HEARING - REZONING APPLICATION AND DEVELOPMENT PERMIT [856/858 ESQUIMALT ROAD]

The Director of Development Services gave a brief overview of the rezoning and Development Permit applications and introduced the applicant who provided an overview of the development proposal and was available to answer questions.

#### **PUBLIC INPUT**

Mark Lindholm, resident, stated that his property was directly affected by the proposed development; however generally he was in support of the application. He expressed concern for access to commercial uses and with the number of visitor parking. He supported the "white roof" concept proposed for this strata-titled building because of its lower maintenance issues than a "green roof" concept.

Kathleen Ironmonger, resident, stated that she lived adjacent to the subject property and that the proposed building would affect her views. She was concerned about additional traffic, pedestrian safety and the impact on sightlines of the two towers.

Alexandra Innes, resident, expressed concern about the ongoing construction, and with the proposed breezeway attracting criminal activity.

Lilly Thompson, resident, stated that she was impressed with the project and welcomed the removal of the existing pub and recycling centre. She was concerned about shadowing, increased traffic, the blasting during construction and the proposed height of the buildings.

Chris Daley, resident, expressed concern with the blasting to create the underground parking, shadowing of his building and the density of the proposed development.

Willy MacGillivray, resident, stated that this development proposal was setting a precedent for this area and for amendments to the OCP. He inquired as to the vision for this area, and what the developer was prepared to do for the citizens of Esquimalt in exchange for rezoning approval.

Georgina Hesketh, resident, inquired as to why some developers are able to make 8 or 6-storey buildings economically feasible in other communities.

Emmy Labonté, resident, stated that with a second look at this development proposal, the building resembles a European style, was well thought out and would be an improvement over what is currently on the site.

Muriel Dunn, citizen, stated that the proposal was too grand and questioned why the developer needed to have a 12-storey building. She was opposed to 12-storey buildings in Esquimalt, especially located around a school.

Susan Currie, resident, expressed concern with the density of the 2-tower development, and that the developer may run out of money and the townhouses not being completed on the site.

Peter Ryan, resident, stated that he was in support of this project and welcomed the accessibility features proposed.

Lisa Christianson, resident, stated her opposition to the proposed development, noting her concern with traffic congestion and construction noise.

Mayor Desjardins called for additional public input three times and there was no additional input.

#### ADJOURNMENT OF HEARING

Mayor Desjardins declared the Public Hearing closed at 9:25 p.m.

**Zoning Bylaw, 1992, No. 2050, Section 54(5)(c) – <u>Side Setback</u> – an exemption from the required 4.5 metre setback from an Exterior Side Lot Line [i.e. from 4.5 metres to 0 metres].**

(2) Development Permit, 521-529 Comerford Street [Lot 266, Suburban Lot 40, Esquimalt District, Plan 2854], [Lot 267, Suburban Lot 40, Esquimalt District, Plan 2854], Staff Report No. DEV-11-094

A discussion ensued on the parking variance requested by the developer, with general support for the design of the building.

**MOTION:** Moved by Councillor Brame/Councillor Gaul:

That the application for a Development Permit limiting the form and character of development to that shown on architectural plans provided by Vic Davies Architect stamped "Received November 2, 2011", and sited as detailed on the survey plan prepared by Powell and Associates, BC Land Surveyors, stamped "Received September 14, 2011", and including the following relaxations to Zoning Bylaw, 1992, No. 2050 and Parking Bylaw, 1992, No. 2011, for the proposed development located at Lot 266, Suburban Lot 40, Esquimalt District, Plan 2854 and Lot 267, Suburban Lot 40, Esquimalt District, Plan 2854 [521-529 Comerford Street], as submitted, be **denied** due to concerns regarding insufficient parking:

Zoning Bylaw, 1992, No. 2050, Section 24 (1) – <u>Visibility at Intersections</u> – an exemption from the requirement that there shall be no obstruction to the line of vision by Buildings, Structures or vegetation between the heights of 1 metre and 3 metres above the established grade of streets within and area bounded by the centre lines of intersecting streets and a line joining a point on each of the centre lines 25 metres from their intersection.

Parking Bylaw No. 2011, Section 11(1) – <u>Visitor Parking</u> – a reduction in the required number of dedicated visitor parking spaces from 1 of every 4 to 1 of every 26 [i.e. from a total of 13 visitor spaces to 2 visitor spaces]

Parking Bylaw No. 2011, Section 13(1)(a)(v) – <u>Number Of Off-Street Parking Spaces</u> – a reduction in the required number of parking spaces from 1.3 spaces per dwelling unit to 0.46 spaces per dwelling unit [i.e. from a total of 51 spaces to 18 spaces].
