### 1. CALL TO ORDER

Mayor Desjardins called the Regular Meeting of Council to order at 7:00 p.m.

#### 6. 2012 PROPERTY TAX RATE PRESENTATION

- (1) 2012 Property Tax Rates Power Point Presentation by Laurie Hurst, CAO
- (2) 2012 Property Tax Rates, Staff Report No. ADM-12-025

The Chief Administrative Officer gave a Power Point presentation on the 2012 Property Tax Rates options.

#### Council comments:

- Appreciate eight scenarios presented by CAO;
- Need to provide low property tax rates for 2012, in a responsible manner;
- Having an Economic Master Plan will give Council more information.

**MOTION:** Moved by Councillor Hundleby/Councillor Morrison:

That Council direct staff to prepare the 2012 tax rate bylaw reflecting a 2.49% tax increase where the 2012 budget reflects the contingency amount and the contribution to Capital Projects Reserve Fund amount at levels consistent with previous years and establishes a reserve fund for potential future policing costs with an initial contribution of \$60,000.

**CARRIED** (Mayor Desjardins and Councillor Brame opposed).

**MOTION:** Moved by Councillor Brame/Councillor Hundleby:

That \$2115 be taken out of "Grants - Local" and be included with "Council Membership Fees - Tourism Victoria".

**MOTION:** Moved by Councillor Hodgins/Councillor Morrison:

That Council direct staff to enter into a Financial Strategic Planning process, connected to the Economic Master Plan process, to explore options to reduce the tax burden to "Business" class by Fall, 2012.

Administration

(1) Animal Control, Staff Report No. ADM-12-024

The Manager of Corporate Services presented the Animal Control report and answered questions from Council.

- designates Animal Control Officers employed by Victoria Animal Control Services Ltd. as Animal Control Officers for the Township of Esquimalt;
- b) appoints Victoria Animal Control Services Ltd. as poundkeeper for the Township;
- designates the Victoria Animal Control Services Ltd. facility located at 564 David Street, Victoria BC V8T 2C8 as the Township's pound; and
- d) gives first, second and third readings to Animal Bylaw, 2002, No. 2495, Amendment Bylaw [No. 4], 2012, No. 2788.

# Engineering and Public Works

(2) Options for Sidewalk Location on Wordsley Street – Sidewalk Construction Program (2010 – 2018), Staff Report No. EPW-12-006
