Mr. David Hurford, on behalf of Mr. Ray Parks of the Capital Region Music Awards Society, made a PowerPoint presentation regarding Greater Victoria's bid for the 2014 Juno Awards event and answered questions from Council.

Mayor Desjardins declared a conflict of interest due to her son being in a local band, and she left the meeting at 7:32 p.m. Councillor David Schinbein took the Chair as Acting Mayor.

### Council comments (Response in italics):

- Concerned about economic benefits to areas outside the centre of the event activities, such as Esquimalt;
- What are the school legacy opportunities? *Provision of musical instruments and performance opportunities to showcase local talent;*
- What is the funding expectation? Victoria paying extra; other regional municipalities asking for \$1 per head, plus appointment to Working Committee and letter of support; timing of receipt of funding is flexible.

This Committee recommends to Council that the Township of Esquimalt pledge support for the Victoria bid to host the 2014 Juno Awards, to a maximum amount of \$17,000 (\$1 per person resident in Esquimalt), funded over two fiscal years (2013 and 2014).

### RECOMMENDATION:

**That** the Committee of the Whole recommend that Council assign one member of Council to sit on the "Community Economic Development Strategy Task Force"; and furthermore

**That** the Committee of the Whole recommend that Council assign one member of Council to each of the proposed sector round tables.

### **BACKGROUND:**

Council has identified, "Economic Development Strategy: Terms of Reference", as part of its 2012 Strategic Priorities Report. During recent budget deliberations, Council asked staff to report back with an outline of the proposed process for the development of a "Community Economic Development Strategy". Staff have prepared a <u>Draft Community Economic Development Strategy Process Document</u> (Appendix "A") that outlines a proposed process for gathering information to develop a "Community Economic Development Strategy". The proposed process is based on a series of sector round table workshops. The following sectors are recommended:

- Developers and allied professionals;
- Education and training:
- Environment:
- First Nations
- Health and wellness (includes physician recruitment);
- Local business;
- Shipbuilding and defence; and
- Tourism.

In addition, a "task force" would be established comprised of one member from each sector round table and one member of Council. The "task force" would have the following responsibilities:

- Act as a coordinating body for information provided by the sector round tables;
- Help guide the development of the inquiry framework for the sector working groups;
- Help recruit participants to the sector working groups;
- Provide insight into the issues affecting Community Economic Development in Esquimalt:
- Provide insights into their sector;
- Participate in the review of documents produced by staff including but not limited to:
  - Background information given to the sector working groups; and
  - Draft reports from the sector working groups
- Recommend policies, strategies, and actions for the Community Economic Development Strategy;

The proposed process would be managed primarily in-house with initial outside consulting limited to professional facilitation of one or two of the sector round tables and the proposed half day Community Workshop. However, through the process, areas may be identified for further study that may require the expertise of specialized consultants. Staff would likely request budget allocations for these studies, if required, in the 2013 budget process.

### ISSUES:

Esquimalt's economy is currently going through a transformation from an economy that was thought to be in decline to an economy that could lead Esquimalt to become a "Global Centre of Excellence in Shipbuilding and Repair". In order to maximize the potential opportunities provided by this transition it is imperative that Council and the community be guided by an economic strategy that will form a framework for decision making related to community economic development.

It is important that residents of Esquimalt are engaged in the process of developing the Community Economic Development Strategy. It is proposed that a "Community Forum" be held in November 2012, at which time the public would be invited to provide input and feedback into the process before the actual Strategy is drafted. This would help ensure that the community is engaged in the process.

It is also important that the process be kept fairly simple in order to make the best use of the time and resources allocated to this project.

It is expected that the costs related to having several of the sessions facilitated by a professional facilitator will cost between \$1000.00 and \$2000.00 dollars. Staff will try to use existing "consulting" budget allocations to cover these costs. If any additional expenses arise in 2012, staff will return to Council with a request to reallocate budget from another area.



- Attracting new investment;
- Increasing the commercial and industrial tax base; Land Use;
- Property taxation policies to promote economic and social well-being; Business attraction and retention;
- Attracting young workers;
  - Infrastructure needs;
    - - Marketing; Workforce;
- Regional issues; and

The results would be summarized in a matrix similar to the one shown on Table 1.

## 2. Community Economic Development Strategy Process and Timeline

The proposed process and timeline is as follows:

Due to the need to prepare for maximizing the economic benefits of the shipbuilding industry, it is suggested that the Shipbuilding and National Defence round table be held in early June. The other round tables would be held in the fall after the summer holidays.

## 3. Getting from "Vision" to "Action"

It is proposed that prior to attending the round table workshop, each participant would have completed a workbook which contained a number of questions related to the sector. For example:

- What is your vision for this sector in Esquimalt's economy?
- What are the strengths of this sector?
- What are the weaknesses of this sector?
- What are the threats to this sector?
- What are the opportunities for this sector?
- What actions need to be taken to for this sector to reach the vision you have for it in Esquimalt's economy?
