Update on Admirals Road Upgrade Project

### RECOMMENDATION:

That the Committee of the Whole recommends to Council that this Report be accepted for information.

### BACKGROUND:

In 2011, the Township carried out a study to investigate the feasibility of implementing bicycle lanes along Admirals Road between Lyall Street and Maplebank Road in order to transform the corridor from a primarily car oriented thoroughfare to a multi modal corridor (car, transit, bicycle, pedestrian). This project was in support of: Pedestrian Charter, Official Community Plan, Sustainability Charter, Climate Action Charter and Strategic Plan. The results from the study concluded that the existing corridor could support a change in the existing road cross section to include bicycle lanes. Drawings of Admirals Road and the various cross sections are attached in Appendix A.

During the study, the Township was in communication with BC Transit, Capital Regional District (CRD) and the Ministry of Transportation & Highways (MOTH) on how changes in the Admirals Road cross section could impact their individual operations/current projects (E&N Rail Trail). The information received from these parties indicated that they approved and supported the changes.

At the same time, the Township was also exploring how to make a positive impact on the quality of storm water entering into Esquimalt Harbour. It became clear that additional measures could be undertaken to improve the quality of storm water entering the receiving water body. This work would include the separation of combination manholes (current Township initiative) and the addition of mechanical treatment systems (i.e. oil/water/solids separators).

Based on this information, a scope of work was determined for the upgrade of Admirals Road. The scope of work included:

- Installation of mechanical treatment systems for storm water;
- Separation of sanitary and storm water collection systems at common points;
- Addition of bike lanes:

- Addition of turning lanes;
- Addition of traffic calming islands (complete with plantings and irrigation);
- Addition of banner holders;
- Addition of LED street lighting (for trial purposes);
- Asphalt overlay;
- Reduction from four lanes of traffic to two lanes;
- Reduction of on street parking.

Funding for this scope of work was pursued two ways. The first submission was for funding from the General Strategic Priorities Fund (GSPF) administered by the Union of British Columbia Municipalities (UBCM). The funding request for the entire project as detailed was for \$2,800,000 with the funding being 100% dollars. This funding request was made in 2011 and in 2012 the Township learned that it had not been successful. Subsequently, UBCM has issued a call for submissions for projects under this fund. The Township has reapplied for this funding.

The second funding source was from the Regionally Significant Project Fund (RSPF). This fund is issued by UBCM to regional areas (i.e. CRD) to carry out regionally significant projects. The Township's scope of work for this submission was reduced from the previous submission with a total budget of \$750,000. The scope of work for this submission is:

- Addition of bike lanes;
- Addition of turning lanes;
- · Painted islands;
- Localized asphalt replacement;
- Reduction from four lanes of traffic to two lanes;
- Reduction of on street Parking.

The Gas Tax Regionally Significant Projects – Working Group (CRD/staff members from the municipalities) ranked this project number 4 out of the submitted projects. The group has also given its endorsement to this project. Engineering will be preparing a project submission to UBCM by late summer.

### **ISSUES:**

The primary issues facing the project at this time are whether or not it will receive funding from the two funding sources and when the Township will receive this funding. The project submission to GSPF supports a number of the objectives of the program; however this project will be evaluated on its merits and against projects submitted from municipalities throughout the Province. It is staff's opinion that this submission will receive a more favourable evaluation during this intake as a portion of it does have regional support.

The submission to RSPF is on solid footing for approval. These monies have been set aside by UBCM for the region to decide how to best utilize them. The project does support the goals of the funding source and has received CRD endorsement. It is staff's opinion that this funding will be granted.

When the funding will be received is another issue facing the project. It is being assumed that an announcement on the GSPF funding would occur in early 2013. The Township has not had any experience with RSPF funding but it has been assumed that this funding will be available either late in 2012 or early in 2013. Once funding has been received, staff will bring forward a

report to Council detailing the scope of work to be undertaken and how will this work be carried out (i.e., detailed design, public consultation, etc.)




# Segment One - Lyall Street to Esquimalt Road









# Segment Two -Esquimalt Road to Colville Road









### **RECOMMENDATION:**

The comments on the City of Victoria's proposed Official Community Plan that are attached as Schedule "A" to Staff Report No. DEV-12-027 be endorsed and forwarded to the City of Victoria via a letter from the Director of Development Services followed by a letter from the Mayor once Council adopts the recommendation of the Committee of the Whole.

### **BACKGROUND:**

Since January 2010, the City of Victoria has been undertaking a review and update of its Official Community Plan. The City gave first reading to OCP Bylaw 12-013 on April 12, 2012. Pursuant to Section 879 (2) (b) (iii) of the *Local Government Act*, the City of Victoria has sent a copy of their proposed Official Community Plan to the Township of Esquimalt for review and comment.

Staff have reviewed the proposed Official Community Plan and generally find it well researched, well organized, well written, and sympathetic to the goals and desires of the Township of Esquimalt. Staff have found few items of contention other than the fact that the E and N rail line is not shown on the official "25 year future transportation network" map. Given that significant funding has been obtained to refurbish the E and N rail, it would seem appropriate to have this facility identified as part of the 25 year transportation network.

Staff have found a number of opportunities where cooperation between the two municipalities could have synergistic benefits. These include protecting the ecologically sensitive north shore of West Bay and protecting the aesthetic integrity of the entrance to Victoria Harbour.

A more detailed summary of staff's comments are found in Schedule "A". Due to time constraints (comments must be received by the City of Victoria by June 14) it is proposed that the items in this Schedule be put into a letter format, along with any deletions, additions, or edits desired by Council, under the signature of the Director of Development Services with the proviso that the comments have not been officially adopted by Council. Once Council adopts the recommendation from the Committee of the Whole a letter would go out from the Mayor's office indicating that the Township's comments have been officially adopted by Council.

### ISSUES:

In staff's review of the document, they found very few policies that would be a concern to the Township. In fact, many of the proposed policies support the direction of the Township such as: protecting Victoria Harbour, promoting a hierarch of travel that puts pedestrians and bicycles ahead of single occupancy vehicles, and protecting heritage resources. Staff feel that Victoria's goals and aspirations as described in the proposed Official Community Plan are very compatible with the desires and aspirations of the Township.

In terms of potentially contentious issues, it should be noted that the only reference to a new sewage treatment plant is found in section 11.5.1 that states: "Coordination with Capital Regional District plans and works undertaken, such as new sewage treatment plants".

Staff's only major suggestion for improvement would be to add the E and N railway corridor to Map 5 which illustrates the Victoria Region 25 Year Transit Future Plan.

### **ALTERNATIVES:**

That the Committee of the Whole recommends to Council that:

- 1. The comments on the City of Victoria's proposed Official Community Plan that are attached as Schedule "A" to Staff Report No. DEV-12-027 be endorsed and forwarded to the City of Victoria via a letter from the Director of Development Services followed by a letter from the Mayor once Council adopts the recommendation of the Committee of the Whole.
- 2. That Council revise Schedule A and direct that the comments on the City of Victoria's proposed Official Community Plan that are attached in Schedule "A" to Staff Report No. DEV-12-027, as revised, be endorsed and forwarded to the City of Victoria via a letter from the Director of Development Services followed by a letter from the Mayor once Council adopts the recommendation of the Committee of the Whole.

### Schedule "A"

# Summary of the Township of Esquimalt's Comments on the City of Victoria's Proposed Official Community Plan

- 1. The Township of Esquimalt wishes to thank the City of Victoria for the opportunity to review their proposed Official Community Plan.
- 2. Generally, the Township finds that the plan addresses many contemporary planning issues that will be faced by the City of Victoria and its adjacent municipalities (e.g. food security, issues related to peak oil, issues related to climate change, and issues related to the new economy).
- 3. The Township finds that it can support the majority of the proposed "policy directions".
- 4. The Township strongly supports a number of "policy directions" including:
  - a. 7.14.5 Participating with BC Transit, the Township of Esquimalt, the District of Saanich and the Town of Oak Bay in undertaking the study of options to provide potential cross-town priority frequent transit service connecting major destination including Canadian Forces Base Esquimalt, the Downtown Core Area, Royal Jubilee Hospital, Camosun College and the University of Victoria.
  - b. 7.25.6 Partnering with others to maintain and enhance passenger rail service on the Esquimalt and Nanaimo Rail Corridor including commuter rail service as market and funding conditions permit;
  - c. 10.10 Work in partnership with the Capital Regional District, the Township of Esquimalt, the Town of View Royal, the District of Saanich and other partners to increase coordination in the protection and restoration of Victoria Harbour and the Gorge Waterway.
  - d. 10.11 Work with partners to assess the projected impacts of sea level rise on marine and shoreline ecosystems and respond to changing conditions through management strategies and development of a Climate and Energy Resiliency Plan.
  - e. 14.8 Work with the regional partners to make high priority improvements to transportation infrastructure for business travel, good movement, and visitor arrival including:

- i. Important gateways, such as the Inner Harbour marine aerodrome, heliport, Victoria Airport and the Inner Harbour and Swartz Bay ferry terminals.
- 5. The only major change that the Township would request is that the E & N railway corridor be shown on Map 5 "Victoria Region 25 Year Transit Future Plan." Given that the Island Corridor Foundation has recently received significant funding to refurbish the rail line it would appear as though this project may move ahead in the near future. Given that this project may move ahead well within the 25 year timeframe set out in the proposed Official Community Plan, from a planning perspective, it should be incorporated into the 25 year transit plan. It should be noted that this rail line will also be used to carry freight and resources.
- 6. The Township would also suggest that the various references to demographic data be updated with the latest data from the 2011 Census.
- 7. The Township of Esquimalt looks forward to cooperating with the City of Victoria in helping both municipalities to achieve goals that are mutually desirable.
