Administration

The Sustainability Coordinator presented Staff Report No. ADM-13-026 and answered questions from Council.

  - Esquimalt and West Bay Residents Associations;
  - CRD Inter-Municipal Climate Action Working Group/Steering Committee;
  - Parties having expressed an interest in the guidelines; and
  - The public at large by posting a copy on the website.
- 4. Direct staff to prepare a report to Council in Fall 2013, with a revised <u>Green Event Planning Guide</u> for consideration of approval along with an implementation strategy.

## Finance

(2) 2013 Local Grant Submission, Staff Report No. FIN-13-006

The Director of Financial Services presented Staff Report No. FIN-13-006 and answered questions from Council.

#### **Council Comments:**

- Concern that less than 90% of budgeted funds have been allocated:
- Several like-minded organizations coming forward for support (i.e. 12 groups for children and youth) – suggestion that they work together to decrease costs and duplication of services;
- Feedback from residents who pay taxes expect services for fire, policing, but not to give tax dollars to organizations;
- Chair of the Local Grant Committee stated that the committee ensured that the Local Grant Policy was followed (i.e. "must" appear before committee – if did not, application was not considered); some groups had also requested a tax exemption and were therefore not awarded grant funding;
- Policy states "up to 90% of grant allocation" to be awarded;
- Organizations can apply for a grant throughout the year from unallocated funds:
- Local grants provide for a sense of community as well as services to the community, especially Esquimalt-based organizations.

**MOTION:** Moved by Councillor Morrison/Councillor McKie:

That Council approve the distribution of local grants as set out in the schedule attached to Staff Report No. FIN-13-006, with the following additional grants approved:

- a) Rockheights Middle School (\$1,500);
- b) Esquimalt Community Gardens (\$800); and
- c) Macaulay Elementary School PAC (\$12,130, not \$5,000);

for a total amount of \$55,230 in local grants awarded.

Engineering and Public Works

- 1. Repeal Traffic Order Nos. 141, 1178 and 1188 and that Traffic Order Nos. 1202 and 1203 be adopted;
- Traffic Order No. 1202 that signs and road markings be placed to indicate that parking is prohibited at all times on the North side of Esquimalt Road commencing at the East boundary of Canteen Road and extending to a point 10 metres to the East of the entrance to the Public Works Yard, adjacent to 1390 Esquimalt Road; and
- 3. Traffic Order No. 1203 that signs be placed to indicate "No Stopping" between the hours of 7:00 am and 9:00 am, Monday Friday, on the North side of Esquimalt Road commencing at a point 10 metres to the East of the entrance of the Public Works Yard, adjacent to 1390 Esquimalt Road, and extending to a point 25 metres east of East boundary of Admirals Road.

(5) Traffic Order for Lampson Street Bus Stop Relocation, Staff Report No. EPW-13-016

That Council approve Traffic Order No. 1201 – That a sign bearing the Words 'Bus Stop' be placed, and curb painted red, to indicate that a Bus Stop exists at all times on the West side of Lampson Street, from a point 15.5 metres southerly from the southern boundary of the E & N Railway, thence southerly for a distance of 20.2 metres.
