6. <u>NEW BUSINESS</u>

(1) Urban Agriculture and Food Systems (OCP Review)

<u>GOALS</u>

- Food literacy
- Food resiliency

OBJECTIVES

- Increase number of allotment gardens, community gardens, edible landscapes, food bearing trees and other types of food production activities
- Food access is available, affordable and culturally appropriate
- Promote local food production and distribution as a means to limit transportation energy and greenhouse gas use and food resiliency

POLICIES

- Community gardens
 - Support expansion of allotment community gardens on public land
 - Allow community gardens as a permitted use in all zones
 - Develop mechanisms to encourage developers to include community gardens as part of the design process for restaurants / commercial
 - Encourage gardens and food production spaces in multi-unit residential buildings, including rooftops
 - Establish a minimum lot size for community gardens in multi-unit residential buildings
 - Support community gardens on institutional lands (schools)
- Edible landscapes
 - Encourage food production in suitable public places
 - Planning and plant selection for public gardens, green spaces and boulevards to include food production as one of the selection criteria
 - Identify and preserve edible native and medicinal plants
- Food production on private land
 - No restrictions on placement of food producing plants on private property
 - Support rainwater harvesting and grey water reclamation
 - Support urban farming on private land
 - Support small scale greenhouse and aquaculture practices
 - Protect neighbors access to sufficient solar exposure as new development proposals come forward
 - Expand kitchen scrap collection system to include garden and yard waste plant material
 - Encourage backyard composting
- Food access
 - Allow the sale of products from urban animals and agricultural products under same conditions as business licensing
 - Ensure continued access to sustainable local artisanal marine harvesting
 - Support local markets encourage daily, year-round markets
 - Permit farmers markets in commercial and institutional zones
 - Support the creation of central, multi-use gathering place for food based community activities
 - Supporting food sharing by limiting restrictions on distribution channels
 - Inventory community food access points and identify gaps
 - Encourage local food distributors to make "ugly" food available at affordable prices to minimize food waste
 - Integrate food systems across all land use designations
 - Support agencies and community groups that provide food access to vulnerable population with incentives and grants
 - Golf course support agricultural land protection
- Food literacy
 - Promoting food security initiatives and food literacy (nutrition, food preparation / production, lifecycle input / process of food, minimize food waste, etc. as a resource)
 - Encourage the development and use of community kitchens / commercial kitchens for groups to learn food literacy and skills related to affordable and nutritious food

Other

- Establish a vision that supports food systems and food security and what it means in Esquimalt
